Budget 2021

Bill gives brief summary of assumptions made

Donations are only up to the end of March

Rentals for Manse and Playschool are for entire year – Marlo is working with the playschool to renew their lease

Thrift store estimate is based on estimates from Sally based on the January sales and opening hours. If we can open more later, this may increase.

Pulpit supply and musician are budgeted until the end of March

Caretaker is for the full year at the current time

Admin salary is based on about 1 day per week

Snow removal is the same as previous years

There is also a one-time severance cost in the budget carried over from 2020

Thrift shop honorarium for some volunteers has been taken out of both the revenue line and is included as an expense. – this will be cleaned up

Buildings and grounds is basic maintenance

There has been a request for an inspection. The estimate is \$5500 this is not in the budget

The above assumptions result in a net income of approximately \$1000 this is a small buffer and built on a lot of assumptions

Kitchen and hallway flat roof and repairs may need to be undertaken

If we get an inspection we can get the inspector to estimate the cost for repairing that section of roof – we may have enough money to do the inspection and the roof.

Marlo points out that we might be able to qualify for the \$40 000 loan/grant (pay back \$30 000) COVID benefit

MINISTER'S REPORT - 2021, Rundle

Upon Rev Murray Speer's departure for Calgary at the end of October 2020, as your nearest neighbour I assumed the role of covering emergency pastoral needs at Rundle, and once Rundle made the move from Pacific Mountain to Chinook Winds Region, I formally became the Supervisor at Rundle Memorial United Church. Officially, that remains my role, though I very much consider myself to be "your Minister" and have enjoyed getting to know you throughout 2021. It has been a privilege to become much more knowledgeable about the strong sense of Mission that is expressed by Rundle in the Banff community.

Early in 2021 the Rundle Memorial United Church congregation approached Ralph Connor Memorial United Church in Canmore, to investigate the possibility of amalgamation, or some form of shared journey. Such a venture has many complexities – especially for two congregations of different sizes and with very different modes of raising/generating funds – and it has taken the hard work of many volunteers, with the capable assistance of Rev Joel den Haan from Chinook Winds Region, to build a shared understanding of how these congregations might work together. This work will continue well into 2022.

I know that there is some disappointment within the Rundle congregation that an amalgamation couldn't have happened quickly, but there's good reason why amalgamations typically happen at the end of a two-to-three year jointly-initiated, jointly-agreed-upon process. Simply put, there are endless details to work out from the financial and physical property sides of things, made even more complex with one community outside the National Park boundary and one inside that boundary, and it takes some concentrated effort and openness to make sure that the "people" side of an amalgamation is done well. Having said that, I have been impressed at the willingness of leaders from both congregations to do this work and have seen much of the initial hesitancy fade away along with a growing sense of shared purpose, mission and opportunity. I can say unequivocally that it has been a joy to watch:

- the gradual integration of the two communities of faith, with active participants from Rundle on a number of Ralph Connor committees and in our shared commitment to refugee sponsorship,
- lay readers from Rundle on-screen every second week in our combined online Worship services,
- an Inclusive Wedding Ministry launched between Rundle and Ralph Connor,
- a couple of Ralph Connor volunteers helping out weekly at Rundle's Thrift Shop, and
- when we have been able to meet in-person for Worship, outdoors (3x in 2021, at Millennium Park, Canmore) or indoors (2x in 2021, at Rundle), it really has felt like one cohesive family of faith. I look forward to many more of these connections in the coming year.

As always, at year's end I must offer my thanks for the support of Rundle's governance group, Ralph Connor's council and committees, and the membership of both Ralph Connor and Rundle. In this prolonged liminal time, betwixt and between the ways we used to function as communities of faith, and the unfolding horizon that God is placing before us, much adaptability, resilience and trust has been needed – as well as hours and hours of Zoom meetings, phone calls, prayers, socially distanced walks, and other ways of expressing care for one another. I thank everyone for your continuing efforts, and your support of the Ministry we share.

- Three employees were interviewed and hired for the Thrift Shop. M&P worked with the shop manager for this.
- Although it was inappropriate to have formal meetings, M&P were in frequent dialogue with and received guidance from Rev. Wooley

Further business:

Growing and changing relationship with Banff Rundle Memorial United Church. Congregation has dwindled to about 25, and eight or so worship together. Rundle formally requested that we absorb them, including assets. So far Council and Trustees have "formally received" this letter, and we have set up steering committee. The Steering committee has reached out to Chinook Winds.

There are two very separate pieces of work here: #1 receiving the 25 members to welcome them on a personal level; #2 months or years to deal with property/program assets. It is further complicated by the knowledge that their 1978 Lease was signed with Parks Canada by the General Secretary of the United Church of Canada, rather than local signatories. We keep working on #2, making sure it does not get in the way of #1; today is the last online worship for Rundle. Finances will currently be managed separately. John Cranston reported it could take up to 6 years to complete amalgamation. He described six steps: welcome members, physical property, thrift shop, rental playschool, refugee application, manse rental; noted that it is illegal to sign lease for more than 21 years, which may have led to a 42 year lease being signed at a national level. Original lease 1935 was signed by Stewards of Rundle Memorial, and renewed by UCC.

Currently John Cranston, Dave Somerville, Karen Fraser, Ian Schofield and Greg Wooley serving on steering committee. Do not wish to have stand off with Region or Town of Banff. Dale Stanway may be asked to participate on Steering Committee.

Ruben asked if red flags, lease renewal came up in 2020 to be addressed.

Donna Kennedy indicated Worship to start by inviting members to Sunday worship - recommended Alan Buckingham to lead up Christian Education, and other committees to welcome Rundle participation applying interest and talents. Welcome to RCMUC community of faith.

Closing Prayer: Greg closed with a prayer from Ephesians - Glory to God, who is able to do far beyond all that we could ask or imagine by his power at work within us. Amen

REPORT FROM THE CHAIR 2021 RALPH CONNOR MEMORIAL UNITED CHURCH COUNCIL

Pivot is defined as the action of turning around a point. The word has been used repeatedly throughout this Covid pandemic. But it is an apt word when describing the Year 2021 for Ralph Connor Memorial United Church. In basketball, the pivot foot is the foot that remains in contact with the floor while a player controls the ball while stopped. For many of us, this community of faith has been our pivot foot, allowing us to twist and turn while firmly anchored in place as we faced the continual winds of Covid. Collectively, we moved around Covid, scoring on so many fronts.

I first want to express my thanks to all members of our team who contribute their time, talent, and treasure to provide our faith community and the broader Bow Valley community with a full schedule of support, activities, projects, and initiatives throughout the year. Where do I begin?

Property

Realizing that Covid prevented full use of our Sanctuary and Gordon Hall, the Property and Maintenance Committee (aka The Property Guys) accelerated its maintenance and greening initiatives to take advantage of the quiet. The Property Guys identified the "low hanging fruit" regarding energy-saving projects such as conversion to solar outdoor lights. Energuide appliances. LED lighting throughout, and insulating ductwork in the crawl space beneath the Sanctuary and got these projects done! Additionally, the Sanctuary was painted, and the wood flooring was restored. We are very grateful to the talented, skillful, and hard-working Property Guys and also appreciate the work of the Green Initiative group for their ideas and participation.

We are thankful that many outside organizations supported us financially in these endeavors. The Faithfull Footprints program of the United Church of Canada contributed 2/3 of the cost of our greening initiatives. We participated with Bow Valley Green Energy Cooperative and installed 30 solar panels on the roof of Gordon Hall. We also appreciate the incentive grants from the Town of Canmore and the Alberta government. There will be significant energy savings both financially and through lower gas emissions.

But, we are not finished. Thanks to the admirable and tireless work of the Building Committee, the Federal Government has made a substantial (\$100,000.00) grant to help us make Gordon Hall and the Sanctuary more accessible in 2022/23! Please see the Business and Heritage Committee - Accessibility report for details.

Worship Committee

The ultimate pivoters were the resourceful Worship Committee. Whether by Zoom, by YouTube, at the ball diamond, or in Rundle Memorial United Church in Banff, the Worship Committee and our ever adaptable Minister and Evensong's leadership offered us a full schedule of Worship and Fellowship. Particularly inventive was our Music Ministry. The variety of music offerings was fresh and inspiring. We are very grateful to all.

Amalgamation

Early in 2021, RCMUC was approached by the Congregation of Rundle Memorial United Church in Banff with an amalgamation proposal. Like so many Christian congregations across Canada, there were not enough congregants at Rundle United to sustain the Church and its missions. While the process of amalgamation is being reviewed and considered, we welcomed Rundle to share worship and Church life and have been delighted by their participation and insights. In the summer, we jointly worshipped

at outdoor services in Canmore. We joined Rundle for in-person worship this autumn. Members of RCMUC have volunteered at the Thrift Store at Rundle. A joint committee of Ralph Connor and Rundle Memorial met to consider the next steps. Now a joint financial planning team is working on a Sustainability Plan to allow us to share worship and Church life with the folks at Rundle and to continue and broaden the mission work of Rundle while maintaining the two campuses. Our thanks to all. We expect that the Congregation will be asked to consider and vote on the question of amalgamation in 2022.

Wedding Ministry

Another Bow Valley-wide initiative was our Wedding Ministry headed by Shannon Mang as Minister and assisted by Aurora Borin. This hard-working Ministry has already performed a record number of weddings and will fill the need of both locals and those wanting a mountain destination wedding with a Christian service.

Bow Valley Refugee Project

The Bow Valley Refugee Project is a mission of RCMUC. The resourceful BVRP has settled eight (8) Syrian Refugees to date. BVRP is sponsoring Ahmad Ali, also from Syria and presently in Malaysia, and anxiously awaits his arrival. Rundle is sponsoring the Imran family of four (4) through its "The World is Our Neighbour" mission. BVRP is partnering with TWON to prepare for their arrival, hopefully in 2022. Also, without hesitation, BVRP has reached out with an offer to settle an Afghani refugee.

Canmore Young Adults Network - CYAN

CYAN has been touted as a model for outreach to young adult communities. The revitalized Board of CYAN, the Canmore Young Adults Network, thanked us recently for our unwavering support as they struggled to provide programming to young adults and obtain funding from external agencies. We thank the Friends of CYAN for their mentoring of the CYAN leadership team.

Spiritual Explorations

Spiritual Explorations is the new name for the Christian Education Committee. The Committee wants to provide a variety of programming to deepen our understanding of our Christian faith and explore other faiths and indigenous spirituality. Programing will be offered within our community of faith and also designed to reach out to include the wider community. We are now delivering instructional materials directly to families so they can explore our faith together in their own homes. Our thanks to all.

Living Into Right Relations and Wider Church Community

We are steadily taking steps towards reconciliation with our Stoney Nakoda neighbours and the First Nations and Metis with whom we share the Bow Valley. We are listening, learning, and responding. We thank the Living into Right Relations Committee for the excellent work done to educate RCMUC and the larger community, including such important activities as having an information booth in the church courtyard every Sunday in September, creative and noticeable outdoor educational displays throughout the year (e.g., Red Dress, Every Child Matters, Orange Shirt Day, childrens' shoes), and reacting to the indigenous perspective in the proposed New Alberta School Curriculum. We also appreciate those who are reaching out to us.

Additionally, we appreciate the work of the Wider Church Community and the admirable work of our representatives.

Outreach and Pastoral Care

Covid did not prevent us from caring and doing the excellent work of our Church. Thankfully we are blessed with active, creative, capable people who continue to work hard and have found safe and

innovative ways to continue our missions through our Outreach and Pastoral Care Committees and their projects. These include (but are not limited to) the Prayer Shawl Ministry, Prayer Circles, Tuesday at Two, Healing Pathways, Canmore Food and Friends, the Benevolent Fund, High Strung Ukulele, Threshold Choir, Alpine Voices, Bow Valley Refugee Project, Canmore Young Adult Network (CYAN), Affirming Ministry, and Living in Right Relations. We are most grateful.

Affirming Congregations

Both Rundle and RCMUC are affirming congregations. We strive to be a welcoming and inclusive community through our outlook, actions, and specific programming. We work to make the Bow Vallev a place where all of its citizens feel safe, respected, and comfortable in being themselves and expressing all aspects of their identities.

Stewardship and Trustees

RCMUC is financially solid. The Stewardship Committee led a very successful Pledgefest campaign this autumn. The Trustees adeptly handled our investment funds! Thanks to both committees, we can look to the future on a very positive note. We are very grateful. I also wish to give special thanks to retiring Trustee Chair John Cranston, who has contributed so much to Ralph Connor through his many years of incredible work as a Trustee and as a wise and thoughtful active participant in our Church. He will always be a cherished member of Ralph Connor.

Church Council

We have been blessed by a Church Council who individually and collectively worked so very hard throughout the year. These leaders developed teams who likewise stepped up and did the work. On behalf of the Congregation, I thank the Committee Chairs, the Sub-Chairs, and individual Members of the Committees and Congregation for their outstanding work during this challenging year!

Officers

We also owe a debt of gratitude to our Treasurer, Mona McIntyre, ably assisted by Dave Somerville and Mona's husband, Frank, for their many hours spent on this crucial task. Thanks also to Ruben Nelson, who has done an excellent job as Secretary to the Council and provided thoughtful input during Council discussions.

Ministry and Personnel

Finally, I want to recognize the great work of the Ministry and Personnel Committee and the leadership of our outstanding Minister and Team throughout this challenging year. Our faith community has thrived this year due to their understanding, encouragement, and counsel. Thank you, Rev. Greg Wooley, Trish Campney, Tanya Sullivan, and Jan Tissandier.

EMERGENCY PREPAREDNESS

Shortly after the start of the Covid pandemic, Council formed a Subcommittee to respond to Covid and the public health measures issued by the Governments and the United Church of Canada. As needed, the Subcommittee has met to review the updated public health directives and formulated written policies for our in-person activities and use of our Church property by the congregation and our public users. We have safely pivoted to outdoor services, allowed the use of the Church Hall by our long-term renters, and relished in-person services at Rundle in Banff. The Subcommittee wishes to thank all for their support of our decisions and commitment to safety. We will continue to provide advice as we reopen as the Covid pandemic hopefully recedes in 2022.

MINISTER'S REPORT

At RCMUC, 2021 was a year framed by big societal realities and significant "first steps" within the community of faith.

In my 2020 Minister's Report, I stated that "the final 42 weeks of 2020 required every person and every committee and ministry of this congregation to be continually adaptable...on the whole we did (and continue to do) remarkably well as a congregation, and I thank you all for your contribution to that." Ditto, for all 52 weeks of 2021! The ongoing reality of this pandemic led to many disheartening starts and stops, but we have forged ahead. Three outdoor services at Millennium Park (with two others planned-but-rained-out) and two indoor services at Rundle Memorial reminded us of what it feels like to worship in one another's company. We yearn for more of that, while continuing to turn to God's Word for hope and guidance through our online Sunday services and Zoom'd Evensong gatherings each Wednesday.

In addition to the realities of COVID-19, all Canadians and the RCMUC congregation were brought face-to-face with a hard reality in 2021, through the gravesite discoveries at Kamloops, Cowessess, and other Residential School locations. We knew, from the 2015 Truth and Reconciliation Report (and verbal reports for decades before that) that these gravesites existed but the Kamloops discovery, in particular, was a pivotal moment. I am indebted to the work of our Right Relations committee at making such public, visible efforts to build knowledge and to encourage reconciliation, and I have been humbled by the graciousness that friends at Mini Thni have brought to this shared walk on the path of peace.

Early in 2021 the Rundle Memorial United Church congregation in Banff approached RCMUC to investigate the possibility of amalgamation, or some form of shared journey. While such a venture has many complexities - especially for two congregations with very different modes of raising/generating funds - it has been a joy to welcome the contributions of Rundle folks on Church committees, to become familiar with the important mission exercised by the Rundle Thrift Shop, and to be able to gather in the spacious sanctuary at Rundle as we attempt to return to in-person, indoor Worship. As will be reported elsewhere in this AGM Report, coming together with Rundle has also led to the birth of a new shared Wedding Ministry, which has brought a new vitality to this connection with the broader community. Much progress was made in our "Ralph and Rundle" discussions and this process continues into 2022.

The other "new" area in which significant steps were taken in 2021, was the "greening" of our building. Through the Faithful Footprints program, a partnership between the United Church of Canada and Faith & the Common Good, many upgrades were made to Gordon Hall and to the ventilation system. RCMUC also became the first community-funded solar installation of the Bow

Valley Green Energy Cooperative, and we are so pleased to have solar-generated power meeting much of our power needs as well as contributing to the grid. We look forward to additional facility-related changes that will make the RCMUC building both energy efficient, and increasingly welcoming to all members of the Canmore community.

As always, at year's end I must offer my thanks for the ongoing support of the Council, committees, prayer circles and membership of both Ralph Connor and Rundle. In this prolonged liminal time, betwixt and between the ways we used to function as communities of faith, and the unfolding horizon that God is placing before us, much adaptability, resilience and trust has been needed - as well as hours and hours of Zoom meetings, prayers, phone calls, socially distanced walks, and other ways of expressing care for one another. I thank everyone for your continuing efforts, and your support of my Ministry in your midst.

BOW VALLEY WEDDING MINISTRY

M&P Introduction:

In February 2021, the idea for a Bow Valley United Churches Wedding Ministry was brought to Council. This idea came from considerations about what could be taken off Rev. Greg's responsibilities, to lighten his work load, making it more manageable. RCMUC Council supported further investigation of this idea and in March 2021 Rev. Shannon Mang and Aurora Borin were contracted to conduct research and to produce a report for Council. Their report was shared with Council in June 2021 and, following further discussion, Council approved a motion to accept the report and to move towards implementation of this new ministry. Council members Joy McMann and Cathy Harrop were appointed to a working group to work with Shannon Mang on this project.

Not only does this ministry help Greg, it will pay for itself as the wedding fees will cover all expenses associated with this new ministry AND will add a little bit to the coffers of both churches. A grant was received from the United Church's EDGE program to cover start-up costs, including website development.

While Shannon began doing weddings earlier, a contract was officially signed with her as Wedding Minister in September 2021. See Shannon's report for more on the work of this ministry thus far. Contracts were also signed with Aurora Borin as Wedding Musician and with Marlo Reid as Wedding

Host for the Rundle site. Work is still in-progress to determine the tasks and role(s) of a Wedding Host for the Ralph Connor site and what administration is needed for this ministry.

By all accounts, Greg is happy to not be doing weddings (as they are "destination weddings" rather than for congregants), Shannon is enjoying doing weddings and both she and Aurora are excited about growing this ministry.

BV Wedding Minister:

It has been a fun year shaping the Bow Valley United Church Wedding Ministry in 2021. I enjoyed working with Aurora Borin on the research project in the Spring. I took the opportunity to contact some United Church ministers and wedding ceremony specialists who having developed unique wedding ministries in BC and the Maritimes and I gained a lot of insight about building up and marketing a welcoming wedding ministry. I also gained valuable insights in the meeting with Carla Leon with EDGE who helped us with our application for start-up funding.

The wedding bookings started coming in and I was very busy with doing zoom meetings and ceremony planning with the couples. The changing Covid19 restrictions were challenging, particularly with the indoor ceremonies at Rundle United in Banff. Outdoor ceremonies were certainly less stressful around the pandemic protocols, but the three outdoor weddings in October and November were chilly.

In 2021 there were 11 weddings performed through Ralph Connor Memorial and Rundle Memorial United Churches. In mid-January 2022 we already have 11 weddings that have been booked between the two communities for the coming year, so I anticipate that there will be more weddings performed than last year.

I look forward to using the EDGE grant funds in the coming months to develop the wedding ministry website and marketing materials. Both Aurora and I were very excited with the potential creation of a uniquely Affirming Wedding Ministry as we worked on the project proposal. This continues to be a passion area for me. I hope that soon we will be known in the LGTBQIA2+ community across Canada and beyond as the place to have fabulous inclusive weddings in the beautiful Bow Valley.

This past year, Covid 19 has once again challenged the Worship Committee to keep up with protocols and restrictions in providing meaningful and engaging services for the congregation. Many thanks to the entire committee for their ideas and energy. Special thanks to Greg for his devotion and extra work; Tanya for her recordings and work with the virtual choir; and Jan for her organization of Evensong. Their efforts are appreciated by all who have watched online or attended in-person services.

Faith@Home: Packages have been purchased and are being mailed out to families with young children. The response has been that these have been excellent resources. Children's Church/Christian Education has now been given to the newly formed Spiritual Development Group.

Evensong: Services continue online with many people volunteering to lead services. Participants include worshippers from not only the Bow Valley, but Calgary, the West Coast, and England. We are thrilled these services have been able to continue and that the participation has been very satisfactory.

Choir: Tanya continues to record hymns and anthems for the online services. She has developed a good repertoire to be used. The choir has been meeting virtually, then individually recording themselves to be mixed by Rick Anderson. Thank you Rick for your time and talent. Other members of the congregation have provided musical offerings from time to time.

Outreach: Greg continues to send an online service to GEV once per month. He was able to do an inperson service in December, which was much appreciated by the residents and staff. To offer support to our healthcare and essential workers, the bells were rung on Saturdays at 2:00 pm in June and July.

Pie Day: Julie Fletcher and Ali Buckingham from Rundle, led this activity with 16 participants.

Red Dress Day: The church was adorned with Red Dresses and posters to provide information regarding the acknowledgement of murdered and missing Indigenous women. Comments were positive regarding this display and many people paused to read the information and take photos. This will be expanded next year with a take away information brochure.

Moment for Reflection: The sanctuary was open for a couple of hours once a week in the fall, for anyone who wanted to sit quietly and reflect and pray. While we did not have many people take advantage of this opportunity, the ones who did were appreciative of the opportunity.

Services: During the process of amalgamation with Rundle United Church, we have had some members from Banff participate in the services. We were fortunate to be able to have three outdoor services in August and September at Millenium Park. Two services were also held at Rundle United Church; one in November and one in December with required safety measures.

Indigenous Sunday (June 20): Tony Snow and other participants from Morley provided a very meaningful and thought-provoking service that was very relevant and reflective of the tragedy of the residential schools and the discovery of many unmarked graves.

We continue to be grateful for their involvement with our church.

Baptism: A baptism was held at our outdoor service in September and another was held with a small family group in the sanctuary.

Communion: We pre-recorded communion to be included in the service. We continue to brainstorm how we can have communion safely once we are back to in-person services.

Remembrance Day: Thank you to Lynn Katarey for her research on three members of the Bow Valley who gave their service in the First World War. This was very informative and added a local dimension to the service.

Christmas: The Mountain Hometown Christmas video from 2020 was updated with some new musical selections and scenes from Rundle United Church.

The Worship Committee continues to strive to enhance worship experiences through services including Sunday Worship, Evensong and other special services.

Since the first meeting in March 2021, the committee has:



- 9. A multitude of fellowship host opportunities explored pending lifting of Covid restrictions and permitting serving of food. The two venues considered are hosting fellowship following in-

person worship, and the other is introducing a monthly Muffin Thursday, stay tuned to the newsletter when these in-person fellowship opportunities can be restored.

AFFIRMING MINISTRIES

2021 Summary:

One of the benefits of the new relationship between Ralph Connor and Rundle, is that both congregations are Affirming Ministries of The United Church of Canada, so our Affirming Committees have been working together. Thanks to all involved!

Some highlights of our work in 2021:

- Shannon Mang convened a study group on the book *Queer Virtue*;
- Julie Fletcher and Ali Buckingham co-hosted a "PIE Day" Zoom event in March;
- The first "Canmore Pride" event included a display and book discussion at the Canmore Museum and RCMUC's Affirming group was represented at both;
- A community discussion regarding having a "Gay-Straight Alliance" in the Bow Valley has begun, with both RCMUC and CYAN represented;
- Robin Slater provides the weekly "Robin's Web" item for the Friday Newsletter, which keeps us abreast of events and reminds us of the breadth of what it means to say we are striving to be welcoming/affirming/inclusive.

As Affirming Ministries, we are especially grateful for the work done in 2021 by the Living Into Right Relations Committee, for making such Public, Intentional and Explicit displays in front of the RCMUC property.

BOW VALLEY REFUGEE PROJECT (BVRP)

The Bow Valley Refugee Project (BVRP), is an outreach mission of RCMUC. The membership of BVRP consists of both individuals from RCMUC and many community members including its President, Debra Hornsby. Joy McMann, is RCMUC's Council representative and several members of RCMUC participate on BVRP's Board.

We are delighted to report that all six (6) of the first refugees that we sponsored in 2016, a family from Syria, became Canadian citizens in 2021! All are happily adjusted in Canada (Canmore and Drumheller) and are very grateful for the assistance of Ralph Connor and BVRP.

In July 2021, BVRP completed the required one-year sponsorship period of providing financial support to cover basic expenses and settlement support for the two Syrian Refugees/Permanent Residents who arrived in the summer of 2020. Some non-financial assistance in helping them to adjust to life in Canada continues to be provided by BVRP. Both have moved from Canmore (Calgary and Invermere, BC) due to our high cost of living and are currently self-employed. BVRP's most recent application is to sponsor the brother of one of these refugees. He is also a Syrian who fled Syria and is currently living in Kuala Lumpur.

BVRP has provided some non-financial support to *The World is Our Neighbour* (TWION), an outreach mission of Rundle Memorial United Church (RMUC). TIWON was created to make a refugee application. This support has included such things as progress inquiries to the government, general advice, and participation in Zoom calls to the four potential refugees from Pakistan who fled to Nepal because of religious persecution against Christians. Covid 19 has been a barrier and the processing of the application has been slow but we are optimistic that some progress is now being made.

BVRP has been in contact with *Canadian Women 4 Women in Afghanistan (CW4WA)* to offer the possibility of sponsorship of an Afghan refugee. Unfortunately, there are some current difficulties for these potential refugees to get out of Afghanistan.

COVID-19 continued to have a huge impact on CYAN (Canmore Young Adult Network) in 2021. Between COVID restrictions to activities, board members leaving and Tara Koenig (CYAN's staff person ince 2018) leaving CYAN for new career adventures, there was a great lull in the energy moving in and towards CYAN. Caylee LaBranche and Stew Moffatt are largely credited with keeping CYAN going. But then, an amazing thing happened! Over the course of 2021, many new board members joined CYAN, enabling Stew and Caylee (eventually) to step aside and focus on other aspects of their lives. In the last months of 2021, CYAN events were back on track, funding for 2022 was secured and the new board members are energized and excited about CYAN fulfilling its Mission.

<u>CYAN's Vision statement</u>: "We envision an inclusive Canmore where young adults thrive and play an active role in the community"

<u>CYAN's Mission statement</u>: "Strengthen Canmore by connecting young adults with each other, local resources, and empowering their voices in the community"

As of December 2021, the CYAN Board consists of: Peter Giraldeau as Chair, Carolyn Reid as VP Fundraising, Sash Steele as Secretary, Brando Hadfield as Treasurer, Graham Scriven as a Member-at-Large, and Gabby Myre, Program Coordinator.

The Friends of CYAN (FoCYAN) continued to offer support, encouragement, and feedback to the CYAN Board members, although regular meetings became challenging. In 2021, FOCYAN members were: Ian Schofield, Ruben Nelson and Joy McMann from RCMUC, Laura Wellmann, from FCSS, and Marci Segal, a Canmore community member. We express our heartfelt THANKS to each FoCYAN member who gave their time, energy, ideas and encouragement in support of CYAN.

RCMUC's support of CYAN continued through donations and acting as CYAN's fiscal trustee. Within RCMUC, CYAN continues to be seen and treated as the young adult community outreach project to which we in Ralph Connor committed at our 2016 AGM.

2021 Survey Results

In the fall/Winter of 2021, we surveyed 92 people. We wanted to compare the results with our survey conducted in 2020, to find out how we're doing and how we could do better

Here's what we found!



92% of respondents knew who CYAN was before taking the survey.

Our Visibility

66% feel like CYAN has helped them become aware of resources available in the community.

39% felt like there were enough activities & events to help connect with other young adults in our community. 45% felt neutral about this.



62% identified CYAN as a bridge connecting young adults to programs & services available in the community.




Why Is That?

People were able to select multiple answers as to why life in Canmore can be difficult.

We found that the four biggest challenges faced by the young adults of Canmore are:

- The lack of affodable housing (56%)
- The high cost of living (54%)
- Financial stability (35%)
- Housing stability (34%)

These numbers are similar to what we found in 2019 & 2020. People love living in Canmore, but it is financially challenging.



In 2021, 71% of respondents said they were interested in volunteering in the community. This compares to 81% in 2020.

Getting Involved

Most people wanted to help out by:

- Helping out at CYAN events.
- Joining CYAN when we volunteer in the community.
- Joining a CYAN working group

51% of respondents felt very connected or somewhat connected to Canmore. This is compared to

57% in 2020





Dear Council Members of the Ralph Connor Memorial United Church,

What CYAN has done in the last year thanks to support from the Ralph Connor Memorial United Church

Over the summer, CYAN hired 6 new volunteer board members (young adults aged 18-35), so we had a dedicated team that was willing to plan and lead events. We are in the process of developing a recruitment process to hire two more Board Members, which will add to our operating capacity while providing training and experience to young adult community members. 2021 was overall a challenging year for CYAN, however, we pulled through with some amazing results.

In Summer and Fall, the new Board decided to reduce our operating costs and run primarily on a volunteer basis, so we could focus our income on reviving our core programming, which had not been operational since 2020. Summer/Fall programming was delivered by our Board of Directors, with the assistance of our paid Summer Program Coordinator. Winter programming was fully delivered by our paid Program Coordinator. Further, CYAN created a volunteer VP of Fundraising role to develop and implement a 12-18 month fund development project, which should be fully implemented by the end of 2022. Under this structure, CYAN delivered the following programs:

Yoga in the Park

We were able to re-start our weekly yoga events throughout the summer at Riverside Park from July - September. Yoga was provided by-donation, and provided a safe and healthy space for young adults to increase their physical and mental wellbeing. Several of our Board Members took turns exercising leadership skills by supervising our Summer Program Coordinator to run this event, which involved booking yoga teachers for weekly events, marketing the event over Facebook and Instagram, and providing resources such as yoga mats and hand sanitizer at the events.

Yoga in the Park regularly had between 15 - 25 attendees on a weekly basis, and provided a venue for young adults to informally meet and strengthen their interpersonal connections. This event was sorely needed after a year or more of COVID-19 restrictions.

Going into the fall/winter, CYAN is running by-donation indoor yoga at the Town of Canmore Recreation Facility, which commenced in late October. Each week, attendance has been approximately 20-25 people, and again has been an important way for CYAN to bring young adults in the community together.



Move Mountains

CYAN's crowning achievement this year was hosting our Move Mountains Festival, which centers around young voter encouragement and political participation. We focused MMF 2021 on the municipal election. We invited the mayoral and councilor candidates to attend, so they could interact with Canmore's young adults, and young adults could ask them questions about issues that were important to them. Unsurprisingly, affordable housing and the environment were the hottest issues of the evening. Further, the musical component of the evening was performed by Northern Quarter, a local band from Canmore that won Calgary Music Awards 2020 - Group of the Year.

We hosted this event at the Cornerstone Theatre on Thursday October 14th, 2021, one month after the provincial government implemented new COVID restrictions and also the Restriction Exemption Program. As a Board, we decided to run a hybrid event, with in-person and virtual attendance options. We had over 50 in-person attendees and 30 virtual viewers. All audience members (virtual and in-person) were able to participate in this event through the use of a mobile application called Slido, which enabled attendees to submit questions to the Master of Ceremonies (Rob Murray, Mountain 106.5 FM), to be answered by the mayoral and councilor candidates.



Pasta Night

In addition to the events run above, CYAN re-started Pasta Nights. Pasta Night is a by-donation event that is run-monthly, COVID restrictions permitting. We partner with the local business community, who donate food (pasta, produce, bread, cookies, olive oil, etc) to help us run this event. Our core sponsors are Canmore Pasta Co. Save On Foods, JK Bakery, Evoolution, and Valbella Gourmet Foods. Run by 6-10 volunteers and one central coordinator, Pasta Night attracts upwards of 30+ people per event, and contributes to the food security of young adults. At each event, we recognize our sponsors by tagging them in our social media posts (followings of approx. 1800 and 1100 people on Facebook and Instagram respectively), and putting their logos on our table stoppers, ensuring high visibility of our sponsors to all participants.



Board Game Night

This in-person Board Game Night was a highly anticipated monthly event during pre-Covid times. It was put on hold over the last 20 months due to restrictions, however, after nearly 2 years, we have just re-launched this event in November and plan to bring it back on a monthly basis during the winter months. The event takes place at Communitea Cafe and is a huge hit, with approximately 20 young adults attending each event. Communitea Cafe graciously provided us space and stayed open until 8pm for us to run the event.

The event provides an opportunity for young adults to have an activity to attend in the evening where they can socialize and meet other like-minded individuals. There is no charge for young adults to attend, however they can purchase something to eat or drink if they wish to. There is no pressure to spend money.

Other notable CYAN achievements include:

- Unmute Your Mic Parts 1 and 2: This event enabled young adults to virtually connect with each other while COVID restrictions persisted into early Summer 2021. This event was MC'ed by the Mountain Mumblers, which gave them a chance to increase their brand presence amongst the young adult community in Canmore while locals shared their talent with the community.
- Canmore Mystery Tours enabled young adults new to Canmore to explore Canmore by following a scavenger-hunt through the town.
- CYAN Annual Survey: We developed our annual survey to understand the current needs of young adults. This year's survey was tailored to understand how the pandemic is currently affecting this demographic. Our Program Coordinator sent the survey out to young adults in November / December, and we received over 90 respondents. The results were summarized for the Board to develop its 2022/23 strategic plan.
- Participated in the Bow Valley Primary Care Network forum in October 2021, presenting ideas on healthcare gaps that are important to young adults.
- We have developed a fund strategy and commenced its implementation in May 2021. Since implementation, CYAN has fundraised approximately \$57,000, of which \$40,000 will be used

towards 2022 programming. Based on the attached budget, this is sufficient to hire an executive director at 20 hours per week for 2022. Additionally, pending additional funding discussed in Note 1 of the attached budget, CYAN should have enough funding to hire a program coordinator at 20 hours / week from April - December 2022.

These accomplishments would not have happened without the support from the RCMUC. Overall, by reviving our programming, we have been able to impact the lives of over 150 community members this year by improving community connections and supporting local businesses like The Cornerstone Theatre, local musicians such as Northern Quarter, our local Pasta Night Sponsors, the Mountain Mumblers, and so many more. In the 2022 year, CYAN has four goals: 1) continue to deliver our core programming, 2) staff and volunteer recruitment, 3) fund development, and 4) collaborate with organizations such as Canmore Pride and the RCMUC to deliver inclusive programming which will deepen young adults' connection with the Canmore community.

COMMUNITY FOOD AND FRIENDS

Established in 2013, Community Food and Friends is an Ecumenical/Community venture providing Monday night dinner at St Michael's Hall for anyone who wishes to partake. Ralph Connor was one of the founding Churches, and took a regular turn in providing volunteers from 2013 to 2020. In addition, for many years a dedicated group of dessert-makers would gather once per month in the RCMUC kitchen, under the guidance of Faye Forbes-Anderson. In 2020, the pandemic caused a transition from an in-person meal, to a delivered meal from the kitchen of The Iron Goat Restaurant (with other businesses participating as well) and then transitioned once more to a take-out meal picked up at St Michael's Hall. PROPERTY COMMITTEE 2021 ANNUAL REPORT

January to June 2021

The Property Committee initiates most projects by e-mail and keeps a regularly updated project list. The Property Committee members carry out repairs and upgrades at the church while keeping in mind its heritage designation. At times the Committee reaches asks for volunteers to support our work. Any-newcomers wanting to help manage or do hands on work are most welcome to join us.

The Committee is responsible for the day-to-day care and maintenance as well as hired services such as security, janitorial, snow removal, exterior window cleaning and trades.

Each spring the Committee organizes a volunteer cleaning blitz of the building and grounds.

Additionally the Committee is responsible for liaising with our long-term tenants who want to lease the church facilities. The Committee also acts as a sounding board for miscellaneous short-term property rentals. Thanks to Trish for managing this function for us.

COVID 19 continued to curtail most activities in the church allowing the Committee to complete many energy saving initiative.

Hopefully restrictions will soon be relaxed so that everyone can fully enjoy prayer and fellowship in our improved facility.

As the lead of the Property Committee for the first half of 2021 I am grateful for the patience, support and assistance shown to me by everyone.

PART 2 - July to December 2021

COMMITTEE MEMBERS: Bill Rowe Cam McMann John Snoddy Rod Sullivan

This part of the report continues the previous submission by Terry Tuepah listing the duties shared amongst the "Property Guys":

- 1. Outside Grounds grass cutting, weeding, trimming shrubs, watering and keeping the property neat and tidy.
- 2. Mud Jacked the concrete front courtyard to raise the dip and prevent people from tripping. It may need a touch up this summer.
- 3. Supporting Solar Panel Project researching all areas of the church and recording where savings of electrical power can take place for the committee. One of our members served part time on the solar committee.
- 4. Exterior Solar Security Lights removal of 3 power hungry electrical security lights and installation of 3 solar generated motion sensitive LED lights, and monitoring the night time on/off process.
- 5. A number of trees had to be removed by a contractor to allow for better sun exposure. One of the trees was located in the middle of a section of our white picket fence leaving a 1.5 meter gap. Contact was made with the original fence contractor to order enough fencing

- material to close the gap. Two committee members installed fencing material to close the gap in the fence.
- 6. No Parking Signs (approved by Town of Canmore) were installed on our back fence.
- 7. Re-pointed and set donation bricks.
- 8. A shorter extension ladder was donated to the Church. Two supports were constructed and mounted on the shed for storage.
- 9. Large plywood cabinet in furnace room was taking up too much space especially with new furnaces. The cabinet was taken apart and material stored for future use.
- 10. Storage shelf was constructed (with salvaged plywood) and installed in previous freezer room.
- 11. Replacement furnace filters continue to be changed on a regular basis and recorded on a chart on the side of the furnace.
- 12. One committee member has the responsibility of meeting with potential or present renters of the church facilities and setting up contracts.
- 13. A metal electronic junction box has been installed below the Pulpit.
- 14. A) A children's music program began in September with a new rental agreement hosted by Corina Strim.
 - B) An adult movement program began in October with a new rental agreement hosted by Adrienne Lawlor.

BUILDING AND HERITAGE COMMITTEE - Accessibility

In response to priorities identified by the Congregation during renovation/expansion consultations, the Committee searched for possible funding sources and subsequently applied for a grant from the Canadian Government, Department of Human Resources and Skills Development Canada, for their Enabling Accessibility Fund. Much to our delight, we were informed that we qualified for a \$100,000 grant which we received in October! Our grant request was to retrofit the door operators at the main door into Gordon Hall, to develop two (2) barrier free washrooms, and to install a 3 stop, front - rear entry elevator for access to the Sanctuary from Gordon Hall and the 2nd floor.

We are also grateful that RCMUC also received a substantial donation of \$10,000 in 2021 that was specifically targeted for making our property accessible. We have used some of these funds to reengage Transept Architecture to revise the concept plans provided during the Congregational consultations into a single concept plan focusing on the accessibility piece. The floorplan redesigns the offices, kitchen, and storage areas, but even so, it is clear that the addition of accessible doors, an accessible elevator, and accessible washrooms will take away a considerable amount of our current space. Accordingly, in order to maintain and somewhat enhance a functional main floor gathering space, the plan envisages a partial (12 foot) expansion into the backyard. This consolidated concept plan accompanies this report.

The Committee is working with a local contractor to cost the project. He did the HVAC work for the Faithful Footprints projects, and there is a consensus that we could work well with him as a Project Manager on this project. It is clear that the scope of the work outlined will cost more than the \$100,000 grant.

We have a lot to do in 2022! Time is of the essence as **the grant must be spent by October 21, 2023,** or we must return it to the Federal Government.


Our next steps, not necessarily in order, will include:

- Determining the costs of the project.
- Consulting with the Trustees regarding funding the project and possible fundraising initiatives.
- Taking the project before Council to ask them to set a Special Congregational Meeting.
- Preparing a report for a Congregational meeting and requesting consideration of a motion approving a detailed accessibility renovation and expansion plan.
- Reviewing the plans with the Planning Department of the Town of Canmore.
- Reviewing the plans with Alberta Heritage because RCMUC is a Provincial Heritage Resource.
- Having a congregational meeting in March or April 2022.
- Investigating and looking for more Government Grants, especially Alberta's Community Facility Enhancement Program, which has an intake of June 15, 2022.

It is important to note that Chinook Winds Regional Council is the ultimate arbiter on matters of significant renovations/expansion of Church Property and the use of Church investment funds. We will have early discussions with Joel Den Haan of Chinook Winds Region.

We are a committee of four, all of whom have other Council or Trustee responsibilities. We would like more help to do the investigations and prepare the report for the Congregation. We welcome additions to our Committee.

We have been given a unique opportunity to improve our building to make it accessible to a broader community, improve our office and workspace, and enhance our space for meetings and fellowship of the Congregation and the wider community.



FAITHFUL FOOTPRINTS and GREENING INITIATIVES 2021

The United Church of Canada Faithful Footprints program helps congregations reduce their carbon footprint. The United Church has committed to reducing its greenhouse gas emissions by 80% across Canada by 2050. This program offers its Congregations grants towards energy conservation and renewable energy projects.

When maintenance was required over the past ten years, RCMUC opted for green solutions including high efficiency furnaces, orderly replacement of fluorescent lighting as tubes failed, and a new roof with high-quality shingles. This year we are very grateful that we received a Faithful Footprints grant, which has allowed us to accelerate and complete our greening initiatives.

First, we had to prepare an energy audit. The Property Guys (aka Property and Maintenance Committee) and the Building Committee collectively had the expertise to conduct a DIY Energy Audit. In addition to participating in a solar panel project with Bow Valley Green Energy Cooperative (BVGEC), our team identified several other projects that would contribute to energy efficiency and reduce greenhouse gas emissions. Faithful Footprints agreed to contribute 2/3 of the cost of these projects for a total of \$23,350.00. The Town of Canmore also funded \$1,250.00 for our solar panel project. The Province of Alberta contributed a total of \$2,340.00 towards the LED Exit signs, the conversion of fluorescent lights to LED, and insulating the duct in the crawl space under the Sanctuary.

Three months after energizing the 30 solar panels, we produced 1,590-kilowatt hours of electricity. That output is roughly the equivalent of the electrical consumption of one (1) Alberta home for three (3) months. The panels have offset the equivalent of 900 kg of CO2 or the equivalent of 400 litres of gasoline. Imagine the energy production during the spring and summer months! We own 49% of the power produced by our solar panels. We buy the balance from BVGEC, which covers all transmission and maintenance costs. BVGEC uses the "profit" to fund more solar panel projects in the Bow Valley, reducing more greenhouse emissions in our neighbourhood.

There are intangible benefits. The addition of LED lighting has made Gordon Hall and offices warmer and more inviting. For aging eyes, LED lighting facilitates easier reading. The most noticeable difference has been improved air quality with the Heat Recovery Ventilation system. Our staff appreciates the fresh, filtered air, especially given the decrease in indoor humidity, which we experienced this past summer with high temperatures and forest fire smoke. We believe that the days of a cold Narthex and uneven heat in the Sanctuary are now past because of our improvements to airflow and insulation of ducts. Other "low hanging fruit" completed during the past year included duct cleaning, solar-powered outdoor lights, Energuide appliances, and smart thermostats. We are proud that all of these initiatives cost the Congregation less than \$9,000.00.

At the end of next year, Faithful Footprints will provide us with an updated performance report measuring the difference in our energy use compared to the energy baseline report based on earlier years. We will then be able to calculate the financial savings arising from this expenditure. We will also be able to quantify the reduction in greenhouse gas emissions we can expect for years to come.

HERITAGE COMMITTEE REPORT

The Heritage Committee is teaming up with the Canmore Museum utilizing its *Places that Matter* and its *Stories That Matter* webpages as a platform to store and make available to the wider community stories, photos, and objects which tell the stories of Ralph Connor Memorial United Church and the people, events and things that help define who we are as a community of faith in Canmore since the arrival of Rev. Charles Gordon, aka Ralph Connor as a young missionary in 1889. We will be assisted by one of our congregants, Ron Ullrich, Executive Officer, and his talented team. Visit the Canmore Museum website to see the exciting projects that are been undertaken.

This is particularly exciting because the opportunity for us to contribute is boundless. To date, we have submitted a short history of the Church and a short biography of Ralph Connor complete with photos. The beauty of the digital platform is that we can add biographies of our Ministers, architectural details of the Sanctuary, history of the memorial windows, the Church as a community hub, and the backstories of our artifacts such as our baptismal bowl. As photos and stories emerge our pages can grow.

There are many other ways to tell our stories. We can open our Sanctuary to visitors during Miners' Day, Open Doors programs, and develop storyboards to deepen the visitor experience as they tour our Church and its grounds. One of the programs being developed by the Museum is "Canmore Chronicles", a selection of "brisk theatrical presentations" that visitors can choose from. Each performance can provide entertaining insights into the fascinating story of RCMUC. We have the talent in our congregation as demonstrated by our Christmas and Easter pageant. We are only constrained by our time and talents.

WIDER CHURCH

Chinook Winds Region Highlights

Greg Wooley. Dave Somerville and Mary Shearer represent Ralph Connor at the Region Level. We have not had a person-to person meeting over the past two years and perhaps 2022 with also be online too.

The regional office is in Okotoks. Rev Stephen Harper is the new Minister of Pastoral Relations. There are some full time regional staff and some staff who work for a number of regions and staff who work at the national level. The "Executive" of the region is elected at the AGM and are volunteers. Presiding Officer is Rev. Vicki McFee.

Chinook Winds Region (Southern AB) and Pacific Mountain Region (BC) work closely together under the leadership of Executive Minister Treena Duncan. Treena continues to lead both regions very successfully through the Covid Pandemic. Pacific Mountains is a large region on a firm financial footing with many staff at the regional level. We are fortunate to be associated with them. They fund a number of programs and events in which we are included.

Over the past year Ralph Connor has received very good service from Chris Mah Poy in children, youth and young adult programming and Indigenous Relations and Zoom meetings. He works for both regions. Rev. Joel Den Haan has provided excellent leadership as we work through the joining of Ralph Connor and Rundle churches. Tony Snow, Indigenous Lead for our region, has produced spiritual resources, national Indigenous connections and online church services. He has visited Ralph and Rundle a number of times.

National United Church/General Council Highlights

The Very Reverend Richard Bott is our moderator and Rev. Michael Blair is the General Secretary. They are leading the church in deep understanding of who we are and what we should become. The recommendations of this effort will be available in 2022. General Council has provided many online sessions on a wide variety of topic to seek input and keep churches and ministerial staff up to date.

On the Financial side, the information sharing and support provided by the United Church of Canada and our Chinook Winds Region have also been instrumental in helping Ralph Connor to identify and secure significant Grants funding available to support our Mission ex) \$100,000 Federal Building Accessibility Grant; \$20,000 CEBA Federal pandemic support grant; \$4,000 Government of Alberta COVID expenses grant for Faith Based charities; and Faithful Footprints grant funding to support Ralph Connor's environmental stewardship initiatives

I (Mary) have been a lay member of the National Council since 2017. Covid resulted in the cancellation of national gathering so we were asked to say on. However in July 2022 the General Council gathering will be held in Calgary or online and my term will end. My connection has served Ralph Connor well as I have been well informed of national developments such as an increase in our assessment this year at the national level. I have also monitored many of the national newsletters and passed on information to members of our council as needed.

Early in the year we participated in a letter writing campaign to demand changes in the new Alberta Social Studies Curriculum. This curriculum is now under review.


The discovery of unmarked graves on the sites on residential schools sites in May sparked more true public interest in Residential Schools than any other recent event. Ralph Connor reacted quickly by lowering our flag and setting up a display of children's shoes with information. In June Orange Shirt Day was declared a national holiday - National Day for Truth and Reconciliation.

During September the committee developed a month long campaign to raise awareness both in our congregation and the community. The church was stunningly decorated. Every Sunday Ralph Connor Members stood on Main Street to educate people about indigenous issues. Orange ribbon pins, bookmarks and information sheets were distributed to anyone interested. Gloria Snow joined us for one Sunday. We estimate that over 400 people of all ages stopped to learn more or tell their story.

A book study was organized for church members using the book These Mountains are Our Sacred Places by Chief John Snow.

We participated again with Morley Christmas. Church members went to Morley to help assemble Christmas Hampers distributed by the Morley Food Bank. Not everyone is eligible to receive one of these hampers. Especially, elders once they receive OAS cheques. So... we raised money to make sure these seniors received hampers. Mittens, toques. lap blankets, prayer shawls and scarves were also delivered to Morley.

I want to thank the whole congregation for you continued interest and stewardship in Living into Right Relations. We operate on an as-need basis. Committee members are Donna and Marshall Kennedy, Linda Bolen, Marg Suurallik, Sue Murray, Alexine Murray, Joy McMann and Judy Archer act as consultants.





MISSION AND SERVICE (OUTREACH)

There are many outreach initiatives as part of the Mission of Ralph Connor. We take seriously the third point in our Mission Statement.

 to reach out and become an agent for social justice in our neighbourhood and in the global community.

You will read in other areas of the Annual Report about initiatives such as CYAN. High Strung Ukulele, Prayer Shawl, Benevolent Fund, Green Initiatives, Dessert Cooks, Indigenous Initiatives, Evensong, online services, prayer circles. Thrift Store at Rundle and the list goes on. Many in our congregations are also involved in community service initiatives in the greater community.

I want comment on our role with Mission and Service at the National level. When the United Church Mission and Service Unit send out appeals for a Hurricane in Haiti or the needs for Covid vaccinations in Africa, we respond. This is not reflected in our budget. Some give monthly donations to KAIROS, a social justice wing of the United Church or subscribe and donate to Broadview. If you want more information about Broadview or KAIROS please contact me, shearermary04@gmail.com.

Our annual givings this year to Mission and Service were over \$14,000. For a church of our size our givings are very generous and we have been honoured for this. These monies are spent in variety of ways.

- 1. They are dedicated to maintaining chaplains for hospitals and universities, large urban missions and educational facilities.
- 2. Twice a year churches can apply to their region for M&S grants. We have received funding for some Ralph Connor projects.
- 3. Other monies are set aside to help our 70 partnerships around the world. One example is The Amity Foundation in China which offers a wide variety of programs to support those on the country's margins.

Thank you all for your generosity in helping others in need and acting as agents for social justice.

BOARD OF TRUSTEES

This is the report of your Board of Trustees for the year ended December 31, 2021 There are six trustees (John Cranston, Randy Nichols, Barb Profitt, Jim Ridley, Carole Rowe, and Rev. Greg Wooley), who meet quarterly. Copies of the minutes are available for viewing in a binder kept in the church office.

The primary responsibility of the Trustees is to manage the portfolio of investments purchased with the proceeds from the sale of the manse. The manse was sold by the church in March, 2004 with net proceeds to the church of \$353,848. The income from this portfolio is provided to the church to offset a portion of the cost of the housing allowance provided to the Minister. In addition, the Trustees are responsible for maintaining the market value of the portfolio at the original value of the manse sale adjusted for inflation. This requirement was originally established by the Presbytery which ceased to exist in 2020 but the Trustees decided to continue to follow this guideline. About 40% of the portfolio is invested in short-term bonds with the balance in blue chip securities selected in concert with the Trustees' investment advisor. This is a shift from the original goal of 50% caused by the significant increase in the value of equity investments later in 2020. After discussion, the Trustees have decided not to take action to readjust this at this time. Part of the rationale for this is that good fixed income investments are very hard to find and have very low returns. A copy of the portfolio is available for viewing by any member of the congregation. In 2021, the Trustees were able to provide \$15,000 for Church operations. The requirement originally set by Presbytery was that we maintain the capital value of the portfolio at the funds received from the sale of the manse plus

inflation was not well defined. To establish a working benchmark, the Trustees decided that inflation would be defined as the Alberta All Items Inflation Index which is published by Statistics Canada. Based on this Index, the target value for the portfolio at the end of November, 2021 (newest available) was \$490,462.00 The portfolio value at December 31,2021 was \$711,366.84 Based on the same Index, the minimum contribution by the Trustees to the church budget in 2021 would be \$12,474. In mid 2021 the Trustees decided that the amount of \$15,000 was getting out of line with the housing allowance established by the national church and set \$20,000 as the contribution amount beginning in 2022. Presbytery has been disbanded with the re-structuring of the national church and the requirement set by the previous Presbytery is no longer in effect. However, the Trustees have decided to maintain the policy previously established unless there is some good reason to change it. Investment markets in 2021 were quite good and the portfolio achieved a return of 16.2%.

The Trustees also invest monies on behalf of the church which are not subject to restriction, except by decision of the Church Council. The Trustees hold \$6,704.11 in Memorial Funds donated to the church by various individuals in memory of loved ones. This amount is in addition to memorial funds held by the church treasurer. This amount fluctuates with additional donations and withdrawals for various projects as determined by the Church Council. In 2021, the Trustees added \$491 to this fund to represent income earned on the fund.

The Trustees have also established a "reserve" fund to provide funds for unexpected needs relative to the church building. The sum of \$400 is added to this fund every month. The balance in this fund at the end of 2021 was \$9,606.72 after two withdrawals. The first was \$7,500.00 to repay the church for its portion of the Faithful Footprints program. The second was \$11,493.28 to fund purchase of the solar panels now on the roof. We have been assured by the church council that 2/3 of this amount will be repaid early in 2022 from a grant from the national church and will be returned to the Trustees.

In addition to the management of the portfolio, the Trustees have an oversight responsibility for the Church property. We report that appropriate insurance coverage is in place and that the church is in good physical condition for its age. The Trustees continue to work with the long-range planning and property committees to determine the need for any future repairs and replacements for the church building.

During 2021, the current Chair of the Board of Trustees, John Cranston, gave notice of his intention to resign at the annual congregational meeting in 2022. After a search, three new Trustees were selected to add to the Board. Gus Campbell, Rick Hester and John Thorburn will be offered to the congregational meeting for appointment to the Board at the annual congregational meeting in January.

RALPH CONNOR and RUNDLE RCMUC AGM REPORT 2021

Over the course of 2021, numerous Zoom meetings under the heading, "Rundle and Ralph Connor" ("R&R" for short) have taken place. Some of these meetings have focused on structural or financial considerations, while others have been focused more on the "people" side of finding a shared pathway for our two congregations. Participants have included Chairperson John Cranston, Karen Fraser, Ian Schofield, Dave Somerville, Dale Stanway, Tanya Sullivan, John Thorburn, Faye Forbes-Anderson, Sandy Penrose, Mona McIntyre (Ralph Connor), Marlo Reid-Gibson, Ian Brownlie, Allan Buckingham, Bill Fisher (Rundle), and Joel den Haan of the Chinook Winds Region.

Rather than attempting to recap all of these meetings, the following motion - which was passed by Ralph Connor Council in November 2021 and the Rundle governance group in December 2021 - outlines much of what has been accomplished by the financial/structural aspect of our R&R deliberations thus far:

WHEREAS Rundle Memorial United Church, Banff, has voted in favour of pursuing amalgamation with Ralph Connor Memorial United Church, Canmore, at a duly-called congregational meeting in December 2020;

AND WHEREAS subsequent to the amalgamation vote by the Rundle Memorial congregation, leaseholds and business arrangements for the Preschool, Manse residences, Thrift Shop and other operations at Rundle Memorial United Church have been reviewed and updated to the satisfaction of Chinook Winds Region;

AND WHEREAS revenue analysis at Rundle Memorial has indicated that revenue stabilization and net positive cash flow will be achieved by end 2021;

AND WHEREAS the Rundle Memorial United Church Board has authorized an initial cash transfer to Ralph Connor Memorial United Church to assist with Ralph Connor's 2021 operating costs;

AND WHEREAS a facility study conducted by Pinchin of Calgary has yielded a thorough understanding of predicted facility maintenance expenditures at Rundle Memorial, which can be supported with appropriate revenue planning from Rundle's own operations without burdening Ralph Connor Memorial finances;

AND WHEREAS Rundle Memorial United Church, Banff, and Ralph Connor Memorial United Church, Canmore, have the opportunity to deepen their ministry and mission engagement throughout the Bow Valley by continuing to work together;

THEREFORE BE IT RESOLVED that Ralph Connor Memorial United Church and Rundle Memorial United Church establish a joint financial management group, comprised of equal representation from each community of faith under the oversight of Chinook Winds Region Community of Faith Strategy Group effective 1 January 2022.

AND BE IT FURTHER RESOLVED that the joint financial management group consider financial operations at both locations, making recommendations as appropriate to each congregational governing body, with the goal to develop a business plan including projected revenues and anticipated major expenditures for shared congregational operations beginning in late 2022. A


review of overall financial operations will be undertaken under the auspices of Chinook Winds Region not later than 30 April 2022;

AND BE IT FURTHER RESOLVED that should joint financial planning yield a suitable business plan for both communities of faith in light of the aforementioned evaluation, the congregations be invited to pursue next steps in amalgamation by 30 June 2022, subject to approval by Chinook Winds Region.

Much work has already been done, and much work still awaits. For more information about the very encouraging progress made on the "people" from of our "R&R" efforts in 2021, please refer to the Minister's Report in this AGM Report.
