

- Anne commented that setting up the family in the manse was a good idea!
 Rev. Greg added his agreement.

lan offered thanks to Rev. Greg and others.

• Rev. Greg offered appreciation for the Wedding Ministry. 'It is an unexpected gem that he doesn't have to do and loves how it evolved.' Thanks to Shannon, Aurora and Marlo for making it happen. Great start to an Inclusive Affirming Ministry.

Finance Update from Bill:

- statement on screen
- profit and loss comparison ... offerings down \$11,000 but total better than a year ago.
- #7415 donation to Ralph Connor UC for what Rev. Greg has offered us.
- #7700 Thrift Store. Over \$40,000 higher than last year. Sally / Ian ... thank you to members from Ralph Connor are also assisting.
- #7740 grants. We applied for a CIBA grant in June, 2022
 - \$20,000 applied to 'World is Our Neighbor', so this is now up to our pre-COVID amount.
 - there is also a loan component.

Expenses:

- #8191 Thrift Store salaries are down... some severance was paid
- #8230 Insurance > previous annual was \$9,630.00 (last year was low) approach was changed... 2022 - \$10,000 plus
 - > UCC switched to monthly payments
- #UCCC assessment DONE 2020 and 2021 paid in advance.
 bottom line ... expenses lower than previous year; surplus due to 2021 profit from Thrift Store and grant/loan

Questions:

Anne - Did we use 'legacy money' for plants? They look very nice for weddings etc.

No money was spent, as 'Pat' and family, donated funds for the plants.

Anne will be coming in May and could plant pansies.

Sally mentioned that there is a donation of \$500.00 from Pat this year and she will check what the instructions are for use of the money.

Anne wondered how the Thrift Shop income was so amazing, as start was slow. Over the year it simply progressed wonderfully.

Clean Up:

Ruby thanked Sally and Ian for their work.

Ian and Kelly were thanked doing the shoveling.

Marlo cleaned and coordinated others.

New flooring is awesome, really looks great.

Play-school chipped in!

Thx to all!! We shall do this yearly.

Balance Sheet - Bill:

Highlights

- We are healthier. 'World is Our Neighbour' fund has grown back to Pre-Covid.
- #1001 Loan with CIBA of \$40,000 must be re-paid by December 31, 2022.
- #2475 thx to Dave Somerville!

Bottom line - much better than a year ago.

Thanks was expressed to Bill; he commented on the great partners he had during the year.

Budget:

- #7220 Manse. We will have income at least until the end of April, as the lease expires then. Folks will then go to month-to-month rental, so the family from Nepal can move in when they arrive. This will also give us time to clean and renovate the house as needed.
- #7415 Donation to Ralph Connor, the equivalent of loose change and PAR, was given in appreciation of Rev. Greg's Ministry among us.
- Thrift Store has a \$7000.00 per month projection, so \$115,000 coming in.
- Changes from last year Buildings and Grounds up a bit due to inspections

 no new planned projects, but going ahead with stonework and stucco, and
 work on the flat roof.
- #8215 snow removal ... going forward we need an insured contractor, so there will be costs to that.

Insurance:

- \$14.000 might be high but needed.
- Fire Alarm inspection was needed, costs to that.

Marlo reminded us that there are also monitoring costs.

Net income of \$5000.00 plus

Bill asked if there were any questions/comments re: Budget?

Kelly expressed delight that this was the first time in a while, that things look positive.

Question from Sharon. Could the arrival of the family from Nepal happen quickly? It was noted that the medical checks were in November. Security checks will be happening soon, but due to the situation in Ukraine this might change.

Bill said that our budget does cover some of the other things, but the family might need to use 'World is Our Neighbor' account.

Rev. Greg commented that things could get put off due to the situation in Ukraine. We will only know... when we know. Could be 5 days or 5 weeks.

Rev. Greg expressed how he enjoyed getting to know folks. 'Things have been interesting. Lot's coming our way as we discover the full expression of our Mission.'

'Fundraising will be exciting! It will be a good year! Perhaps March 20th, we will meet in person. Wed. March 2nd, Ralph Connor will be having a meeting re: Covid guidelines. Thx all.... good start. '

RUNDLE MINISTRY & PERSONNEL Annual Report 2022

In late spring, the M&P committee from Ralph Connor Memorial United Church reached out to us, in anticipation of working together. We discussed makeup of the respective committees, and how we function especially in relation to paid employees. It was reassuring and motivating to know that regardless of the upcoming decision, we are part of a larger United Church community.

Cat provided plenty of notice that she intended on taking a lengthy break. She had potential replacements lined up. Ruby and Ian were able to take on some overdue assignments like cleaning windows, while Kathy performed the standard cleaning work. For the rest of the year, Cat continued her valued work keeping the sanctuary and shop clean, working with us to refocus work when worship or weddings were conducted in the sanctuary. We tend to forget that any schedule "change" has an effect on her work and therefore please make an effort to advise Nancy of anything planned so that she can advise Cat accordingly.

Nancy continues to keep the office and operations flowing smoothly. We are blessed with her ability to handle issues with the building and property, swiftly and efficiently.

There were a few departures and new staff for the Thrift Shop. We work to support Sally with any interviews or requests to change paid hours.

In recognition of the rapidly increasing cost of living, we negotiated higher wages for the staff purposely in September, so that new wages were fully recognized before an amalgamation vote in Canmore.

The Thrift Shop continues to run well in 2022.

- Diabetes revenue from weekly bags to Calgary (unwanted items) \$1,690.64.
- 11 active volunteers presently/ varying time commitments.

- Free items are given to those in need / refugees as needed.

- Management role development

RUNDLE PROPERTY Annual Report 2022

We continue to work through the Pinchin report and the Intact Insurance loss inspection report to guide us. As to what needs to be done and trying to prioritize appropriately.

A full electrical inspection was completed by Henrys Electric in March 2022.

A full boiler and plumbing inspection was completed by Banff Plumbing in March 2022.

Banff Fire and Safety tested and upgraded our alarm system. ABSA completed their annual Boiler Room inspection.

Snow removal continued on a volunteer basis throughout the winter and spring of 2022. Thank you so much to Ian, Allan, Alli, the thrift shop team, the playschool volunteers and some random acts of kindness. It was a big job, but no one slipped and fell to my knowledge. Fall of 2022 we set up a contract with JBT for the Banff Avenue Portion. Shoveling of the rear parking lots and sidewalks continues on a volunteer basis.

Landscaping was handled by a group of volunteers, watering, lawn mowing, trimming, weed killing. We even had a special return visitor- Anne Wilson put in some spring effort.

The Parks Canada, 42 yr lease agreement, is still in process but in its final stages.

The playschool has undergone a \$75,000 upgrade/renovation. Funded by provincial grant, the Pauw foundation and local families. This included new wood fencing around the entire property, painting of interior hall walls and Travis Hall. The largest portion was spent on a little playground, with rubber surfacing. Surfacing is still not installed at time of this report. A new lease was prepared with the playschool, even though this was done in 2021, Parks Canada required some amendments to their sublease with us. We also included some new liability and maintenance responsibility section in response to the addition of the fencing and playground.

The lease with Jesus Rock of Ages Ministry was reengaged, then they left in summer.

I have been part of the Town of Banff Heritage Resource Action Plan Engagement Session, representing the non-profit sector. It is in its early stages, but I have learned that Rundle is on their heritage inventory list. I won't get too much what this means as it really is not impactful at this time, but could mean funding, special assistance in the future for building maintenance as they revamp their program. I will continue to engage with this group and share as appropriate.

Ruby did some major building cleaning and reorganizing- the storage area at the front of the sanctuary, and the office was cleaned resulting in 30 boxes of shredding.

BJ remains ever faithful to the building and probably should be the one doing this report. As he continues to visit regularly stay on top of everything Rundle. Apply the band aids, respond to the

phone calls of concern, meet the trades people and inspectors. Actively applying his knowledge and energy to this space on the regular.

The Manse was a whole major undertaking of its own this year and will be updated in a separate report.

MANSE RENOVATION Annual Report 2022

January 2022: Termination of lease notice given to Manse tenants for 30 April 2022.

May 2022: Locks at front and back doors changed. Thank you to our Ralph Team - Rev Wooley, Rev Mang, Ann £amp; John Thorburn, Ian Brownlie, Sally McDonald £amp; son, £amp; nephew, Bill £amp; Ruby Fisher. N.B. Clean Sweep waved all fees. A decision was made to knock down a wall installed by / Banff Life. This restored the original house layout with a decent living / dining room. Also reversed dysfunctional hall closet to create more kitchen cabinet space. Bill Fisher reinforced that hallway and kitchen wall. Volunteers scrubbed all the walls and kitchen floor, and the bathrooms which defied description. Thank you to Debra Hornsby and Rev. Shannon Mang. Every wall on the main floor basement painted. All the ceilings on the main floor were painted. Doug Withenshaw filled holes and primed most upstairs walls and the basement ceiling. Ruby Fisher repaired and painted all skirting boards. Kelly and Marlo Reid Gibson were the evening mudding, sanding and painting team whereas Ruby and Ian continued during the day where they left off. Benjamin Moore provided generous discount on all paint. Canmore Home Hardware provided a discount for bathroom fixtures and vinyl plank flooring including delivery. Bill's Plumbing gave us a "Friends Rate" for some extensive work on plumbing and furnace repairs. Canmore Flooring installed underlay and carpet in the basement again with generous discount.

Caribou Properties approached us late May re rental of the Manse; they had immediate "short-term" staff housing needs. They offered to complete some of the remaining to sweeten the offer, with guarantee to vacate and fully clean the building at minimal notice. We were very grateful for the work that Caribou Properties did to install vinyl planking, light fixtures and painting of stairwell walls. A tenant supervisor from Caribou Properties inspects the Manse weekly per the lease agreement with Caribou Properties.

Ruby called and emailed a letter to all businesses thanking them for their generous donation towards settling our refugees. All businesses understood the housing shortage and had no issue about renting the Manse to help out a local business with staff housing, many of whom fled the Ukraine.

June 2022: two open houses held on June 18 &; 20. About 16 people and 1 dog attended.

Both furnaces were serviced by Bill's Plumbing. Furnace ducts cleaned by CleanAire 2000. Both gave us a reduced rate.

October - November 2022: Banff Playschool received grant which provided new wooden fencing and playground equipment.

THE WORLD IS OUR NEIGHBOUR (TWION)

2022 was a year of increasing hope and frustration regarding the arrival of our family. After a request from the Canadian government for medical examinations for the family in February, we felt a move might be coming.

Having already determined that our manse would be the residence for the family, we therefore requested that the manse leases should not be renewed after April. When the building was vacant, Ruby Fisher immediately began a project to make the manse habitable for a family, rather than four tenants. This involved a very deep cleaning and painting of all the walls, replacing flooring throughout, updating the bathrooms and restoring the main floor to a living / dining area rather than two bedrooms. Ruby and Bill Fisher worked tirelessly throughout May, ably assisted in the evenings by Marlo and Kelly Reid Gibson. A lot of painting was completed by Doug Witherspoon.

When nearing completion, we were approached by a local hospitality company in desperate need for additional staff housing. Given no further news from the government, we reluctantly agreed to rent the manse again, with the proviso that the tenancy would be revoked at any time, with minimal notice, when the family receives travel authority. In the meantime, many of the tenants are workers from the Ukraine, so we are providing a safe place for people torn from their homeland.

Another glimmer of hope arose when the family was ordered to obtain a police background check for the son, who is now an adult.

Then, in December, a representative from the Canadian government travelled to Nepal to interview the family. She then asked them to get another medical check, which they have all passed. The family was advised that the next step is for the Canadian government to request travel permits from the UN, who would then arrange transportation. It seems that the government's plan is to complete authorisation for all the families waiting for approval by Canada at one time. We understand there are around fifteen families waiting.

Our partners in the Bow Valley Refugee Project believe these last checks are indeed the final steps. Once travel permits are authorised, we typically get 4-6 week notice of arrival.

Ian Brownlie maintains regular correspondence with the family, who are eager to begin a new life here. They investigate all manner of things associated with the town, Park and valley, from grocery

stores to sporting activities. The parents are always looking for employment opportunities and the children are even taking courses to improve their employability, while completing school.



COUNCIL CHAIR REPORT 2022

Ralph Connor Memorial United Church is blessed to have the leadership of Reverend Greg Wooley, who is a wonderful, inspiring, and resourceful Minister. We are also blessed to have an abundance of exceptional volunteers who continue to offer their time and talents as we collectively emerge from the pandemic lockdown. I am very grateful to the members of Church Council who have led their teams to restore our pre-Covid in person activities. We are also continuing to use Zoom and hybrid meetings and activities to accommodate those who cannot be present in person, but who want to participate in decisions and activities.

Council spearheaded two particularly important initiatives in 2022 which after much Committee work, planning, and detailed consultation and consideration culminated in two Special Congregational Meetings in September and October.

At our first meeting we approved the Accessibility Upgrades Project. This Project involves the installation of a 3-stage lift/elevator in Gordon Hall which will facilitate more accessible access between Gordon Hall and the Sanctuary as well as to the meeting and storage areas on the 2nd floor. This project also includes barrier free washrooms and a more accessible Courtyard door into Gordon Hall and to the Sanctuary. On behalf of Council, I would like to thank Paul Elfner, for leading the Accessibility Team and specifically for his impressive skill, knowledge, determination, and the countless hours of work he has spent on this project.

The October Special Congregational Meeting formally approved the amalgamation with Rundle Memorial United Church as one community of faith operating from two sites to offer Christian witness throughout the entire Bow Valley. I want to thank the various committees of Ralph and Rundle folks who have worked and are working towards a more fulsome union of all aspects of the amalgamation of Ralph and Rundle. The congregation of Rundle was welcomed to worship with Ralph Connor immediately and some Committee Chairs did not wait for formal amalgamation before reaching out to our Rundle neighbors and integrating them into committee work. On behalf of the congregants of Ralph Connor I want to thank those originally from Rundle who have graciously embraced Ralph Connor and who have integrated us into the mission work of Rundle and proved that as one we can do so much more mission work in the whole Bow Valley.

This Annual Report outlines the many, many activities and initiatives which enhance our worship and spiritual life and provide mission to so many in the Bow Valley Community. We are grateful and proud of our wonderful volunteers and the work that has been done. Music continues to be very important, and we love the work of our Music Ministry and Choir. We also appreciate the support, encouragement and understanding of our Minister, Reverend Greg Wooley, and our staff: Office Administer Trish Campney, Music Director Tanya Sullivan and Evensong Director Jan Tissandier. Our Church Council, Committee members, and the Congregation could not undertake all our activities without them.

At our first Annual Meeting of the amalgamated congregations, we will be approving a new Administrative Structure to shepherd us in the coming years. To those who choose to step back from leadership roles on Council, on the Board of Trustees, and as Committee members, on behalf of the congregation of Ralph Connor Memorial United Church, I want to thank you for your time and talents over the years and your hard work which will ensure that RCMUC will live on in this new structure. For those new volunteers and those who volunteer to remain part of the leadership team, we are very grateful that you will be there to ensure

And to the congregation a sincere thank you for your support, understanding and encouragement during this past year. EMERGENCY PREPAREDNESS

At the start of 2022, the prevalence of the highly transmissible Omicron variant of the COVID-19 virus made it unwise to hold public gatherings, so our Worship services remained online-only until March. The availability of the larger Rundle/Banff facility was extremely helpful to our return to in-person gatherings, and we were eventually able to resume most previous Worship practices by summertime. A number of committees still meet online-only, or blend in-person and online participation, and we have continued providing every-Sunday YouTube Worship services for those who feel more secure worshiping at home.

RALPH CONNOR PROPERTY COMMITTEE ANNUAL REPORT FOR 2022

This report from the Property Committee is a summary of major, minor and some routine issues related to keeping Ralph Connor Memorial United Church in good safe operating condition. When necessary, we call on outside businesses to provide assistance to help solve problems but only with the permission and knowledge of church officials.

The following is a brief list of jobs that required our attention by the Property Committee or by outsourcing contractors which will be noted: front door panel repair due to vandals; repair of trash containers in both washrooms; crawl space lighting and other electrical connections by Rundle Electric; repair of leaking furnace pipe by Breeze Heating; created and mounted outside bulletin board beside west door for Church announcements; scraped, sanded and painted side west door; replaced flags on flag pole; reset kitchen taps; repaired damaged outside electrical post; painted shed door and ramp; trimmed shrubs at front middle entrance; reset stair railings leading to second floor; removed dead shrubs at back of church, set wooden frame work, laid ground cloth and applied stones to help deter rabbits from digging and used all donated materials; mixed concrete to fill sidewalk openings at entrance leading to kitchen; reset new outside security lights replacing the 3 solar lights that proved unsatisfactory; again less damage by vandals at the front door was repaired and painted; kitchen dish sanitizer repaired by contractor Dave Bailey; organized rentals by different organizations; changed filters in furnace and handled a variety of issues related to the general upkeep of the Church and property including grass cutting and weed control of our back grass.

P.S. The Committee would like to draw your attention to 2 issues. For the past year and a half we have managed to have the Property Committee operate without a Leader. It probably would be better to have a Leader. We believe that we should have another member who would serve as Leader. Is it possible that another person could be found?

BUILDING/HERITAGE COMMITTEE'S REPORTS BUILDING/HERITAGE COMMITTEE REPORT

In October 2021, Ralph Connor Memorial United Church was approved by ESDC (Employment and Social Development Canada) for a \$100,000 grant under their Enabling Accessibility Program. Specific items under the grant include a 3-stop elevator from Gordon to the Sanctuary and continuing to the second floor, removing barriers to use of main door into Gordon Hall and building fully accessible washrooms on the first and second floors.

As this funding was contingent on completion by October 2023, the Committee worked diligently throughout 2022 toward formalizing design scope and budget for a project that would accomplish this objective and meet the prescribed deadline - our "Accessibility Project".

In the first half of 2022, design scope was advanced, that also included redevelopment of all washrooms in addition to the accessibility items. Based on this scope, Ashton Construction Services provided us with a budget cost which was set at \$280,000.

A funding plan was also advanced, that included the ESDC funds, a legacy donation, money from the Ralph Connor trust fund, and money to be raised form the Congregation and other sources. As of December 2022, we still needed to raise approximately \$50,000.

A special congregational meeting was convened on September 11, 2022. The congregation voted over 90% in favor of proceeding with the project as presented. Subsequent to the meeting, a Construction Management contract was executed with Ashton Construction Services to complete the project. As of end of 2022, their schedule indicated project completion by May 2023.

Thank you to the tireless and unwavering work by the current Committee members Karen Fraser, Ian Scofield, Greg Wooley, John Thorburn. Thanks also to Sue Nichols and Arie Boekel for their contributions in 2022.

FAITHFUL FOOTPRINTS & GREENING INITIATIVES

The attached should be included in the report. There are three take-a-ways that the congregation may be interested in:

- 1) We now consume less electricity due to the energy savings from renovations through Faithful Footprints
- 2) The energy we do consume costs us roughly 25% less due to changing our rate plan moving from variable to fixed.
- 3) As of March 15 we will for the first time since panels were installed be selling excess power (production vs consumption) over the summer months back into the grid for use as "carbon credits" by Alberta Oil Credits at quite a high rate, (around \$0.28 per kWh). This will earn us monthly credits that will be applied to future bills over next winter when we will back in net consumption mode. The summer sun is our friend.

CHURCH HISTORY

Through 2022 the Church History Committee initiated several activities upon which it will build in 2023. February is Black History Month. In the late forties Charles Hemsley, a young black man worked at the Exshaw Cement Plant on assignment from the head office in Montreal. He led youth and church choirs during his time in the Bow Valley forming enduring friendship with many at Ralph Connor. His contributions were highlighted in the Newsletter and during Sunday service. The Committee is inviting persons interested in our Church History to develop stories from Ralph Connor and Rundle to coincide with these designated months, weeks, and days in our community calendar.

Lynn Katarey sourced recollections of Christmases past from the writings of Ralph Connor and Robert Rundle, which were read during the Christmas pageants and Karen Fraser also provided historical detail from The History of Ralph Connor Church 1891-1881 and reminisced about Christmas celebrations in the fifties and sixties at Ralph Connor and in the wider communities of Canmore, Exshaw and Banff. The Committee wants to expand such offerings on Easter, Thanksgiving, and other Church holidays.

In July, Ralph Connor was delighted to participate in the inauguration of Heritage Weekend, a program of the Canmore Museum. One of the projects, Days Open Canmore, was a two-day invitation for the public to see historic buildings and sites in Canmore. Our Sanctuary which was built in 1891, is the second oldest remaining public building in Canmore. Our brochure which summarizes our Church History was revised and expanded. Copies were made freely available for visitors to Ralph Connor. Story boards with historic photos were also developed to tell our story. We are grateful to the eight RCMUC hosts, volunteers who welcomed and provided more in-depth information to visitors and people from the Bow Valley. We received great reviews! The Canmore Museum will be hosting another Doors Open event during the 2nd annual Heritage Weekend in early autumn.

From time to time, we receive memorial and commemorative gifts, both specific and unrestricted. For unrestricted donations the Committee makes a list of projects approved by the congregation at its annual meeting for the coming year. In 2022, new hymn books were purchased and dedicated in memory of the life and work of Charles Hemsley and Marie Rodda, a significant church and community member who loved music, donated a church organ in 1953 in memory of her husband, Alphonso Rodda. Music continues to play a significant role in our worship and community life. Our current renovations require a new door between the Sanctuary and Gordon Hall. At our annual meeting we will be proposing that Memorial Fund donations be used for this purpose. If approved, this new door will be dedicated in memory of the donors of the existing door and others who ensured that this historic church was maintained so faithfully over the years.

Rundle Memorial Church in Banff also has a long and distinguished history in Banff. Unlike our Canmore Church, which was originally Presbyterian, it was first established as a Methodist Church. The Church History Committee looks forward to exploring and presenting the rich history of Rundle United. Volunteers are encouraged to step up and offer to research and present our proud history of Christian service in the Bow Valley. This Committee needs members to work independently and collectively to preserve our rich history and we welcome interested volunteers.

Thanks to the work of Janis Dougal and Trish Campney, nameplates honoring Mary Rodda and Charles Hemsley were pasted into the books and plastic covers were attached.

Although, microphones in the Sanctuary were also on the list, this was in error. A hanging mic was purchased and installed in the sanctuary in 2021. There is currently \$5379.43 remaining in the fund.

It is noted that before she passed away, congregation member, Jean Slaght, donated a bequest to be used for accessibility improvements to Gordon Hall. Although this was not technically a memorial donation, the Congregation may wish to think about a suitable recognition of her gift to Gordon Hall and to those who use it.

It is my recommendation to Council and the Congregation that for the year 2023 all remaining funds, including those donated, and those attributed and designated for particular use or features, (such as those in memory of Lorraine Fraser and Mary Rodda), be allocated to the purpose of having an attractive, suitable, and accessible door between the Sanctuary and Gordon Hall. It seems to me that plaques could be made to honor new and previous donors of the door.

If any money remains, I suggest additional furniture for Gordon Hall.

Of interest, because the Sanctuary is an Alberta Historic site any additions or revisions in the Sanctuary may be compatible but must not look as if they are historical.

MINISTER'S REPORT

As I prepared to write the Minister's Report for this year's double-duty Annual Report, I followed my usual process: I reviewed the past year, seeking pivotal moments and/or recurring themes. This led to a somewhat perfunctory first draft. And then it struck me: the "usual" task for reviewing a Church year isn't the task for 2022, at all.

The precipice between 2022 and 2023 is a prodigious place to be, for on January 1st, 2023 the entire lived story of Ralph Connor Memorial United Church, Canmore and the entire lived story of Rundle Memorial United Church, Banff, flow in their entirety into a new adventure. It is with humble gratitude that I recall and honour the wide variety of skills, backgrounds, passions and experiences that these communities of faith bring to this new journey. Together we seek the "new thing" that Christ is placing before us even as we acknowledge all the ways we are shaped and informed by everything and everyone that has led to this moment.

In Canmore, our little (originally Presbyterian) Church building and its congregation date to 1891; in Banff, the Church cornerstone dates to 1927, while the congregation itself (first Methodist, then Local Union) dates to 1886. Each of these faith families holds the life stories of generation upon generation of disciples, striving to understand Christ's call in their time and place and to respond faithfully, wisely, and generously. As with any family story there have been miss-steps aplenty; there have also been holy moments and unexpected points of Divine transformation. We give thanks for the lay leaders who have been such committed stewards of this sacred story; and as we look at the photos of those who have served in Ministry - stopping for a moment at the long service of Rev's Lonsdale and Travis (Banff) and MacKinnon (Canmore) - we give thanks for all who have heard the call to come to the Mountains not only to serve not the Church, but to serve with love all people in the community who need God's loving provision and care.

In this past year, as Minister in Canmore and Supervisor in Banff, I have been impressed by the ease and grace with which the proposed amalgamation has been embraced. The 90% vote in Canmore, in favour of an amalgamation already approved by the Banff congregation, is not just an impressive number; it speaks to a widespread willingness to engage a new future, with partners in faith from just down the road. And while many of us are fatigued from continually adapting to all the uncertainties that came with the pandemic, new possibilities are opening before us in this new venture, and that is a good thing - perhaps even "energizing"!. (And if you really want to be energized, make sure you read Shelley Den Haan's writeup about "Ralph Connor and Rundle", later in this AGM report!!)

As of January 1st, 2023, it is my honour and joy to become the Minister of the newly expanded entity known as Ralph Connor Memorial United Church, Banff and Canmore. As this new role presents itself, I give thanks for the efforts of all who have brought us to this place - those directly involved in the work of amalgamation, and those whose efforts date back to the late 19th century, without whom this whole story would have a different pace and shape and theme.

Blessings and gratitude, in the name of God, whom we know as Creator, Christ and Spirit.

BOARD OF TRUSTEES

This is the report of your Board of Trustees for the year ended December 31, 2022.

There are seven locally elected trustees (Carole Rowe, Randy Nichols, Barb Profitt, Jim Ridley, John Thorburn, Gus Campbell and Rick Hester) who meet quarterly with the active advice and counsel of Rev. Greg Wooley who is, by United Church polity, also a Trustee. Copies of the minutes of all Trustee meetings are available from the Chair Carole Rowe or Secretary Randy Nichols.

A primary responsibility of the Trustees is to manage the portfolio of investments purchased with the proceeds from the sale of the manse. The manse was sold by the church in March, 2004 with net proceeds to the church of \$353,848. The income from this portfolio is provided to the church to offset a portion of the cost of the housing component of the Minister's salary. In addition, the Trustees strive to maintain the market value of the portfolio at the original value of the manse sale adjusted for inflation. This was originally a requirement established by the Presbytery, which ceased to exist in 2018, but the Trustees decided to continue to follow this guideline. About 55% of the portfolio is invested in blue chip securities with the balance in short term bonds and cash selected in concert with the Trustees' investment advisor.

A copy of the portfolio is available for viewing by any member of the congregation. To establish a working benchmark, the Trustees decided that inflation would be defined as the Alberta All Items Inflation Index which is published by Statistics Canada. Based on this Index, the target value for the portfolio at the end of December 2022 was \$542,409. The portfolio value at December 31, 2022 was \$621,945. Based on the same Index, the minimum contribution by the Trustees to the church budget in 2022 would be \$13,796. In 2022, the Trustees were able to provide \$20,000 towards the Ministers housing as part of general operations. Annually the amount contributed to the Minister's housing will be adjusted in line with the housing portion of the Alberta Consumer Price Index. Investment markets in 2022 were down and the portfolio had a negative return of -7.81% but this was less than a typical balanced investment portfolio return for the year of -9.58%.

In 2022 the Trustees committed to giving a maximum of \$100,000 towards the accessibility project. \$20,000 as an initial amount on signing of the contract and up to an additional \$80,000.00 if matched by cash donations and pledges made by the congregation. At the end of 2022 a higher than normal amount of cash was being held in a High Interest Savings Account for this commitment.

In discussion with our investment advisor all future potential investments will be subject to an ESG (Environmental, Social and Governance) filter. As socially conscious investors we will receive recommendations based on a set of standards for a company's behavior.

The Trustees also invest monies on behalf of the church which are not subject to restriction, except by decision of the Church Council. The Trustees hold \$6,027 in Memorial Funds donated to the church by various individuals in memory of loved ones. This amount fluctuates with additional donations and withdrawals for various projects as determined by the Church Council. In 2022 additional hymn books were purchased from the fund.

The Trustees have also established a "reserve" fund to provide funds for unexpected needs relative to the church building. The sum of \$400 is added to this fund every month. The balance in this fund at the end of 2022 was \$25,900.

In addition to the management of the portfolio, the Trustees have an oversight responsibility for the Church property. We report that appropriate insurance coverage is in place and that the church is in good physical condition for its age. In 2022 an insurance appraisal was conducted by Normac Insurance Appraisals of Calgary. The insurable value of the Church was increased to 1.4 M from 1.2M to match the appraisal. The Trustees continue to work with the property committee to determine the need for any future repairs and replacements for the church building.

RALPH AND RUNDLE referred to as "R&R"

A November 28, 2022 article on the Chinook Winds Region website written by Rev Shelley Den Haan, Communications & Cluster Support staff, gives a fine summary of the process toward amalgamation. It forms this year's "R & R" report.

Ralph Connor and Rundle Memorial United Church Team up for Wider Ministry to Bow Valley: New Affirming Church for Canmore & Banff has strong community-focused mission.

Effective January 1, 2023, Ralph Connor Memorial United Church in Canmore and Rundle Memorial United Church in Banff will amalgamate to become one church with two campuses under the Ralph Connor name.

The Rundle thrift shop has a significant role in Banff where young service workers come from across Canada and around the world to serve in the tourist industry. These service workers and also young families find affordable household items and other goods at the thrift store.

It's taken 20 months and a lot of careful work to get to this marriage date but what led the way, says Rev. Greg Wooley, was Rundle's clarity in approaching Ralph Connor to amalgamate in early 2021. The Rundle Church clearly identified its passion for its outreach ministries of a Thrift Shop, Community Play School and plans for receiving a refugee family but that it had little energy for the tasks involved in governance and Sunday Worship.

Wooley, Ralph Connor's minister who was also Rundle's pastoral Charge supervisor says, "Because the approach came from Rundle, that was the key. They identified what they had energy for and that was hands-on ministry." The two congregations have been worshipping together since Spring 2021.

Collaboration brings stronger community-focused mission.

John Cranston, a Ralph Connor Trustee, chaired the combined Ralph Connor and Rundle (R&R) committee that carefully worked out the details of amalgamation, ultimately finding that together they have a stronger collaborative ministry to offer the Bow Valley. The committee worked closely with Chinook Winds Community of Faith Strategy Consultant Joel Den Haan.

Ultimately the R&R Committee identified that the new church brings together two affirming congregations with a strong community-focused mission. Rundle has a strong presence in its community with the community play school, thrift shop and manse that provides affordable housing for a refugee family. Ralph Connor has ministries of Right Relations, collaboration with the Canmore Young Adult Network, Bow Valley Refugee project, AA/Al-Anon, community music programming and more. Ralph Connor's well-attended Sunday and Wednesday night worship services are the primary gathering place and hub to energize mission activities. Rundle's mission is expressed through hands-on projects such as its Thrift Shop.

"The traditional idea of a church congregation had disappeared in Banff," said John Cranston. "On a good Sunday, there might have been six people in worship. But the Church was still carrying on with the thrift shop and play school that are very necessary (to the wider community) and financially viable."

"The use of the church space is busy throughout the week."

The need to evolve was "inherently obvious," says Marlo Reid-Gibson, a Banff church trustee. "The use of the church space was busy throughout the week. Worship was not."

Reid-Gibson became part of the Rundle congregation some 20 years ago after moving from Manitoba. Having previously lived close to her multi-generational family, she found her new location lonely. It was her grandfather who suggested going to church. "I was welcomed into the flock. It was like I found a little bit of home."

To Reid-Gibson, that community and the significant benefit of the social enterprise to the Bow Valley area is important; Worship, not so much. It's something that can happen individually, she says. "We're all out skiing. It's just hard to keep the butts in chairs to make offering worship worthwhile."

However, she adds, "A great thing with amalgamation is that when you go to church, there are people there. Canmore still has that strong worship piece."

Ralph Connor leaders admit to cautiously entering the amalgamation conversations. However, says Cranston, "things that we were worried about turned out to not be a problem."

For starters, they were concerned about taking on the large and old Rundle Memorial building. The R&R Committee asked the Rundle Church trustees to commission a building audit that provided them with building costs for the next 10 to 20 years. That report meant, said Cranston, "We were able to look at this fairly sensibly so we aren't sticking our necks out financially." The committee

also discovered that the Rundle Church lease with the National Parks had lapsed and it took several months to get the 42-year lease in place again.

Social Enterprise Model Benefits Wider Community & Church

"The longer we looked at amalgamation, the more we realized maybe we weren't saving Rundle, maybe we were also saving Ralph Connor." Ralph Connor's revenue comes primarily through donations which went down through COVID and are only now going back up. Rundle's revenue comes primarily through the social enterprise ministries serving the wider community and has remained consistent.

The Rundle thrift shop has a significant role in Banff where young service workers come from across Canada and around the world to serve in the tourist industry. Also, while some young families choose to live in the Bow Valley to be near outdoor recreation, that can also mean holding down three jobs to afford to live in the expensive Alpine communities. They find affordable household and other items at the thrift store.

Now, many Ralph Connor people volunteer at the thrift store. As some Canmore members downsize their homes, they are also donating to the Rundle Thrift Store.

Serving a Distinct Alpine Demographic

Wooley says the fact that the two churches serve similar Alpine tourist communities facilitated amalgamation. Banff and Canmore are extremely busy on weekends, in summer and during the winter skiing season. "The reality of a tourist town is you need to look beyond traditional church weekend programming; otherwise you close out involvement from people in the service industry," says Wooley. Weekends for people are Monday & Tuesday. That's why Canmore started offering Evensong on Wednesday evenings in 2001. "We don't get a lot of young working people but they are a part of it," says Wooley.

A Newer Wedding Ministry Expands

In taking on two churches, Cranston was concerned about Wooley's workload and asked the minister, 'What are you not going to do?' Wooley quickly responded: Weddings.

Ironically Wooley saying 'no' to weddings, opened up the possibility to enhance wedding programs as a ministry in what are in reality two destination wedding locations.

Rev. Shannon Mang, also spouse to Wooley, stepped forward to be the wedding officiant as did Banff's former accompanist Aurora Borin and Reid-Gibson as wedding host. (The latter jokingly describes her role as JLO (Jennifer Lopez) in the movie, The Wedding Planner).

"You see a bazillion weddings every week in Banff. I used to ask, 'Why don't we have more weddings?' I didn't understand what it took out of a minister to do a wedding. Ministers see weddings as taking out of their work to build the congregation," explains Reid-Gibson

As affirming churches, <u>the new wedding ministry</u> is clear that it focuses on offering inclusive and equitable weddings. They are creating a website and connecting with wedding partners and participated in the Bow Valley's latest Pride Parade.

"I think weddings are an untapped opportunity for us,' says Reid-Gibson who adds, "I am a hopeless romantic. I haven't made it through one wedding without a tear."

The Bow Valley church leaders also recognized the need to grapple with long-term church viability, like many churches, post-COVID. A 'futures' group is being formed to envision coming realities and options. The new church doesn't yet know how it will celebrate its official amalgamation date. However, Wooley looks forward to opportunities to use the larger Rundle Church for special events and worship services.

Several people served on the R&R Committees during the 20-month process. These included: (From Ralph Connor) John Cranston, R&R Chair; Dave Sommerville; Mona McIntyre; Ian Scofield, Ralph Connor Chair; Karen Fraser, and (From Rundle) Marlo Reid-Gibson; Ian Brownlie; Bill Fisher; Allan Buckingham (council chair at Rundle) as well as Rev. Greg Wooley. From Chinook Winds Region was Joel Den Haan. Kathy Davies, Pacific Mountain Region, provided initial assistance prior to Rundle Memorial returning to Chinook Winds Region.

FUTURES EXPLORATION 2022 Annual Report

In September 2022, Council formed a Futures Exploration Working Group to work on a process for this work.

An open-invitation meeting was held on October 2, 2022 with Mary Shearer, Ian Schofield, Karen Fraser, Sim Stroes-Gascoyne, Ruben Nelson and Joy McMann attending. Out of that discussion, a focus for us was distilled to this question: "What will it mean to be a community of faith in the Bow Valley in the next 5-10 and 10-20 years?" We determined that this question presupposes the answer to these questions: "What Bow Valley, in what Canada, in what world?" "Are there opportunities in this work to engage others in Canmore?" We also determined that the answers will require researching current and future trends, planning a variety of opportunities in which persons can talk and listen deeply, exploring adjacent possibilities and seeing what captures our vision, imagination and passion.

For the remainder of 2022, working group members (Karen, Sim, Ruben and Joy) have focussed their efforts on research. We hope to have at least one event/opportunity in the Spring of 2023 and a series of events/opportunities in the Fall of 2023. Stay tuned! As we begin planning specific

events, we just might tap YOU on the shoulder to come and help us! If you don't want to wait for such a tap, please volunteer by contacting Joy.

Ralph Connor made a clear statement of support for the local Trans community when a local dispute arose on Facebook.

Shannon and Greg continue in their efforts to establish a PFLAG chapter in the Bow Valley. Unfortunately, it appears that the national infrastructure of this organization has diminished during the pandemic, so the project has stalled at present.

As Affirming Ministries, we appreciate the work done by many Church committees and projects to be Public, Intentional and Explicit in our desire to "live into" our commitments. These include: The congregational decision (with a 90% mandate) to make the Ralph Connor building more fully accessible for people with mobility challenges, through the Building Accessibility Upgrades Project. The development of an Indigenous Library and special events led by representatives of other faiths, through the Spiritual Explorations committee.

The highly visible work of the Right Relations committee, including the displays in front of the RCMUC property, and Rundle Memorial's willingness to host the Chinook Winds "Red Dress Day" service on May 5th.

Shannon Mang's participation in Banff Pride's marketplace, raising awareness for our inclusive Wedding Ministry.

Worship Committee's efforts to mark Black History Month in February, and Asian Heritage Month in May.

OUTREACH MINISTRIES: 2022 REPORTS AND 2023 BUDGETS BOW VALLEY REFUGEE PROJECT Annual Report 2022

The Bow Valley Refugee Project (BVRP) is an outreach mission of RCMUC. The membership of BVRP consists of both individuals from RCMUC and many community members. Several members of RCMUC participate on BVRP's Board.

Since it's inception BVRP has successfully sponsored and settled eight Syrian refugees and is awaiting news regarding the sponsorship of the brother of one of these refugees, a Syrian who fled Syria and is currently living in Kuala Lumpur.

2022 has been a quiet year, mostly one of waiting. We have advised the Canadian Immigration Department that we are ready and willing to sponsor a refugee and reached out to Canadian Women 4 Women in Afghanistan with an offer to assist by sponsoring an Afghani refugee. We have also provided some nonfinancial support to The World Is Our Neighbour, an Outreach mission of Rundle Memorial United Church, and we join them in looking forward to welcoming the four refugees that they sponsored. Lastly, we are responsive to the plight of Ukrainian evacuees in need in the Bow Valley and have provided \$1,000 to Family and Community Support Services, Canmore for the purchase and distribution of grocery gift cards to those in need.

In the absence of a Board Chair and Board Vice-Chair, the Director of Operations will take on much of a leadership role, with the direction and support of the Board.

FOCYAN members continue to be: Ian Schofield, Ruben Nelson and Joy McMann from RCMUC, Laura Wellmann, from FCSS, and Marci Segal, a Canmore community member. We express our heartfelt THANKS to each FoCYAN member who gave their time, energy, ideas and encouragement in support of CYAN.

RCMUC's support of CYAN through donations and being CYAN's fiscal trustee continues to show our commitment to this ministry for young adults in Canmore. In the community, CYAN continues to be known as a voice of and access to young adults.

CANMORE YOUNG ADULT NETWORK (CYAN) 2022 Annual Report for Ralph Connor Memorial United Church

For CYAN's 2022 events, 3 out 5 attendees had never attended a CYAN event, which meant that there were new attendees at every event! In total, there were 2205 attendees at events and 174 volunteers.

CYAN's program continued to provide affordable events included the following:

Food Security: Pasta Nights, free cooking classes, discounted Safeway/Save on Food items and giveaways Social: social events for young adults to meet new people and interact with the community, Pasta Nights, volunteer opportunities, volunteer appreciation night, sports, pumpkin carving, Open Mic and Canmore Pride Mental Health: resources, yoga and art therapy Physical Health: cross-country skiing, stand up paddle-boarding (discounted), yoga, mountain biking and disc golf (discounted).

On the Operations front, 2022 was a year of ups and downs. Two very strong board members left CYAN in the latter part of the year and no other stepped forward into the Chair or Vice-Chair roles. Two employees were hired, a Program Coordinator and an Executive Director. Unfortunately, the Executive Director left after a few months, for personal reasons. These vacancies prompted much discussion about a sustainable structure for CYAN moving forward, which resulted in the Program Coordinator, Nicole Eplett, taking on a new role of Director of Operations. Nicole went straight to work hiring for two other new positions (Programs & Community Manager and Sponsorship & Outreach Manager) to be filled in early 2023. With the new structure, there is renewed energy and commitment.

<u>Strengths identified:</u> community connection, event attendance, volunteers, outreach in the community, RCMUC as fiscal agent.

<u>Weaknesses identified:</u> operational structure, sustainability funding, outreach within the greater Bow Valley, transient commitment.

<u>Opportunities identified:</u> outreach to the greater Bow Valley, operational expansion, expansion and consistency of events.

CYAN's 2022 Survey results show that the greatest challenges for young adults in the Bow Valley are: high cost of living (69%), affordable housing (55.2%), financial stability (44.8%), mental health (34.5%) and lack of employment opportunities (31%). Canmore had the highest Living Wage in 2022. Respondents indicated that 82% make under the Living Wage.

AMALGAMATION TRANSITION TEAM Report

Late in 2022, an Amalgamation Transition Team was approved in principle by Ralph Connor Council, and by early 2023 it formed with the following members:

Banff: Allan Buckingham Finance: Bill Fisher

Canmore: Ruben Nelson Minister: Greg Wooley

Chinook Winds Region (consultant): Joel Den Haan

On November 16, 2022 the Chinook Winds Region formally approved the amalgamation of the Rundle Memorial United Church congregation, Banff, with the Ralph Connor Memorial United Church congregation, Canmore, effective January 1, 2023. The resultant Ralph Connor Memorial United Church Community of Faith carries forward the lives of both of the constituting congregations.

A number of things happen automatically when an amalgamation happens in The United Church of Canada. These include:

- the "people lists" automatically merge: anyone who was a member of <u>either</u> of the prior congregations is now a member of the Ralph Connor Memorial United Church Community of Faith; the lists of adherents and households under pastoral care have also merged.
- The governing bodies of the two congregations ended on January 1st, and the full membership of both the Ralph Connor Council and the Rundle governance group merged to form a provisional Church Council, in place from January 1st to March 19th. Today, a new structure (see below) will be voted on, and populated.
- The Boards of Trustees of the two congregations merged. In order to update legal documents, a combined board of Trustees will officially be elected today.

Other items which are not "automatic" have also happened:

- The national statistical office of The United Church of Canada now regards Banff and Canmore as "two preaching points" of the Ralph Connor Memorial United Church Community of Faith.
- We are one amalgamated Community of Faith, but with the two campuses/locations, with very different financial lives, we retain the two charity numbers of the previous congregations. This is a work in progress, to be reviewed at the 6-month mark.
 - o Today <u>a "Board of Directors" will need to be elected for the ongoing Rundle Memorial United Church charity;</u> for clarity, we are recommending that these names be exactly the same as they had been pre-amalgamation.
- The "terms of call" for Rev Greg Wooley changed with the amalgamation. In essence, there are no practical changes from the past two years, with Greg providing pastoral services to Banff, Canmore and surrounding communities, and Rev Shannon Mang conducting the Weddings.

GOVERNANCE STRUCTURE, POLICIES and BYLAWS

NAME

In 2021, when the congregation of Rundle Memorial approached the Ralph Connor congregation with a proposal of amalgamation, it was proposed that we would continue under the Ralph Connor name. With these things in mind, the newly amalgamated entity will be named **The Ralph Connor Memorial United Church Community of Faith** or in this document, simply the Community of Faith. The term "Congregation" refers to the prior-to-amalgamation entities.

INTENT

All of the following motions are subject to the conditions of The Basis of Union and Bylaws as stated in the Manual of the United Church of Canada, 2023 Edition, and subject to the approval of the Chinook Winds Region of the United Church of Canada.

The intention of all of these motions, including the governance structure itself, is to provide a solid and faithful foundation of support and encouragement for the varied and emergent ministries of the Community of Faith, and to provide a space for the sharing of Spirit and wisdom. These structures will be frequently revisited, particularly in the first three years of the amalgamation, to incorporate what is learned as we "live into" this new way of being.

In order to maintain a smooth procedural flow, the general bylaws and policies of Ralph Connor Memorial United Church, Canmore and the bylaws and policies of Rundle Memorial United Church, Banff, pertaining to the operations of the Banff buildings, will remain in place until we are ready to alter them.

GOVERNANCE

As required by the United Church Manual, a Community of Faith will have:

- A governing body (in our case, the Ralph Connor Community Council);
- A Chairperson, Secretary and Treasurer;
- A Board of Trustees (overseeing the investments and the physical property of both the Banff and Canmore locations);
- A Ministry and Personnel Committee (commonly referred to as "M&P"); and
- we are to elect two representatives to the Chinook Winds Regional Council.
- Called/Appointed Members of the order of ministry are considered members of the Church Council and Board of Trustees, and ex-officio members of all Ministry Teams, committees, and boards of the Community of Faith.

The governance model proposed by the Amalgamation Transition Team is shown on the next page. It consists of three components: The Community Council, which is the governing body; the Executive of the Community Council; and the "Big Tent" which provides a point of connection, wisdom and empowerment for all of the Ministries done in the name of the Church. The language of "committees" is being replaced with "Ministry teams" as each of these groups is active in Ministry.

NEW MODEL OF GOVERNANCE: THE COMMUNITY COUNCIL (diagrammed on previous page)

The formal governance of the Community of Faith is provided by The Community Council. This consists of:

the full Community Council (the roles in blue and grey on the diagram) includes representatives from the "standing" ministry groups, plus all members of the Executive; and

its Executive (the roles in grey on the diagram), is a defined sub-group of The Community Council. The Executive will be empowered to carry most of the tasks of governance, management, administration, and oversight, as well as dealing with emergent or ongoing issues that arise between meetings of The Community Council. Two members at large, one from Banff and one from Canmore, will engage in "deep listening" to ensure that the specific needs of the two Church locations are being addressed. Decisions made and actions taken by the Executive will be reported to The Community Council; if further consideration or reconsideration is needed of any actions/decisions of its Executive, The Community Council has the right to do so.

In addition, there is a "Big Tent" gathering of the Community Council, its Executive, and representatives of all the ministry teams that carry out the numerous and varied ministries associated with the Community of Faith. The hope is that inviting all Ministries to participate in the "Big Tent" will help to build interconnection and support within all of our Ministry teams (formerly known as committees and working groups), will help The Community Council and its Executives to know more about these ministries, and will provide a structure of accountability.

We expect a rhythm between meetings of The Community Council, and The Executive. We propose monthly meetings of The Executive, bi-monthly meetings of the Community Council, and quarterly gatherings of the Big Tent.

The Community Council, as well as its Executive, shall invite representatives of Ministry Teams to assist their work, as needed. Conversely, any Ministry Teams that would like to bring a matter to either the Community Council or its Executive are welcome to do so. Meetings of The Community Council and its Executive will be open to all members and adherents of the Community of Faith. In keeping with current United Church polity, adherents/"non-members" of the Community of Faith are eligible for election to The Community Council. In the United Church, a quorum is one-third.

Members of Council (including its Executive) are elected by and accountable to the Community of Faith, typically at the AGM. Representatives to the "Big Tent" are named by Council, accountable to it, and do not need to be elected by the Community of Faith.

FORMAL STATEMENTS: CALL/PURPOSE and AFFIRMING

We recommend that the Mission Statement of Ralph Connor Memorial United Church, Canmore be adopted as the Statement of Call and Purpose of the Community of Faith:

Ralph Connor Memorial United Church's Call and Purpose as a Community of Faith is:

- to nurture the spiritual exploration and growth of all our members and adherents;
- to be an intentionally inviting Christian community that seeks, welcomes and embraces new members;
- to reach out and become an agent for social justice in our neighbourhoods and in the global community.

We recommend that the Mission Statement of Rundle Memorial United Church, Banff will be adopted as the Affirming Statement of the Community of Faith. In keeping with the previous Affirming Statement of Ralph Connor Memorial United Church, Canmore, the statement now begins with an acknowledgement of Indigenous lands:

As a Community of Faith on traditional Indigenous lands, We strive to follow Christ's example in reaching out in love and friendship to all.

We are committed to full inclusion of people, of any age, race, ethnicity, ability, sexual orientation, gender identity, family structure, or personal circumstance, in all aspects of our life together. We are called, in and with the larger community, to grow in faith through study, prayer, and service; to make known God's gracious presence; and to show loving concern to all Creation.

WORK IS ONGOING

There is much that we will learn in the coming months, as we "live into" our new life.

As we implement the new governance model, we fully expect that tweaks will be needed, and as noted above we will be reviewing the "two charities within one community of faith" model at the six-month mark. In addition, we name three areas to revisit as we get more experience as the Ralph Connor Community of Faith:

- 1) we'll need to determine what we call ourselves: will the name "Ralph Connor" be the enduring name for this Community of Faith, or will a new name emerge? We are one community of faith, but is it two campuses? Two sites? Two locations? Two buildings?
- 2) In the long run, how will we articulate our call and purpose?
- 3) How can we shape our staffing model to best support the work we are called to undertake?

May grace and inspiration and a courageous willingness to try new things continue to guide our steps!
